On behalf of ENDEAVOR ENERGY RESOURCES, L.P. application is hereby made for a public hearing to receive evidence concerning the issuance of an order pertaining to the following matters relating to the Haynesville Zone, Reservoir A, in the Bellevue Field, Bossier Parish, Louisiana:

1. To create one (1) additional drilling and production unit (to be designated as HA RA SUG) for the exploration for and production of gas and condensate from the Haynesville Zone, Reservoir A, in the Bellevue Field, Bossier Parish, Louisiana, as shown on the plat attached hereto.
2. To force pool and unitize all separately owned tracts, mineral leases, and other property interests within the proposed HA RA SUG, with allocation of production to each of the tracts within such unit to be on the basis of surface acreage.
3. To provide that with respect to future horizontal wells drilled to the Haynesville Zone, Reservoir A, within the proposed unit, where the horizontal portion of the well is cased and cemented back above the top of the Haynesville Zone, Reservoir A, the distance to any unit boundary and between wells will be calculated based on the distance to the nearest perforation in the well, and not based on the penetration point or terminus.
4. To designate a unit operator and to designate a unit well for said unit, if appropriate.
5. Except to the extent in conflict herewith, to extend the provisions of Office of Conservation Order No. 196-D, effective July 14, 2009, as amended and supplemented by the 196-D Series of Orders, to the unit created hereby.
6. To consider such other matters and issue such orders as may be appropriate and justified by the evidence presented at the hearing.

The Haynesville Zone, Reservoir A, in the Bellevue Field, Bossier Parish, Louisiana was fully defined in Office of Conservation Order No. 196-D, effective July 14, 2009.

By Pre-Application Notice dated October 12, 2009, applicant advised the Commissioner of Conservation, the District Manager and all Interest Owners, Represented Parties and Interested Parties of applicant's intention to apply for the hearing which is the subject of this application. Applicant received no request for a Pre-Application Conference, and accordingly, no conference was held.

A check in the amount of \$755.00 made payable to the Commissioner of Conservation is enclosed herewith as the statutory fee for holding the requested hearing.

This application is being filed in duplicate, and a copy hereof is being sent to Mr. James C. Broussard, Shreveport District Manager of the Office of Conservation, and to each Interested Owner, Represented Party and Interested Party whose name is shown on the attached list.
