

LEGAL NOTICE

STATE OF LOUISIANA, OFFICE OF CONSERVATION, BATON ROUGE, LOUISIANA.

In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Hearing Room, 1st Floor, LaSalle Building, 617 North 3rd Street, Baton Rouge, Louisiana, at 9:00 a.m. on **TUESDAY, JANUARY 13, 2009**, upon the application of **MUNOCO COMPANY**.

At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the **Wilcox A Zone, Reservoir C, SUX**, in the Trout Creek Field, LaSalle Parish, Louisiana.

1. To grant an exception to the spacing provisions of Office of Conservation Order No. 1267-A, so as to permit the Applicant to complete, designate and utilize their Munoco Company-Placid Fee WB No. 5 Well as an alternate unit well for production of oil and gas or gas and condensate from the Wilcox A Zone, Reservoir C, within the unit designated WX A RC SUX, such well location being shown on the plat submitted with the application.
2. To grant status of the previously drilled and completed Munoco Company-Placid Fee WB No. 5 Well as an alternate unit well for WX A RC SUX Tract.
3. To determine that the requested completion wellbore will enable a more effective and efficient drainage of a portion of the reservoir which can not otherwise be drained by any other well located therein, absent approval of the exception to spacing provisions.
4. To designate Munoco Company as the Operator of such alternate unit well.
5. To consider such other matters as may be pertinent.

The Wilcox A Zone, Reservoir C was defined as being that oil and gas or gas and condensate bearing interval encountered between the depths of 3,740' and 4,996' (electric log measurement) in the H.L. Hunt-Goodpine No. C-6 Well, located in Section 29, Township 8 North, Range 3 East.
