Dear Mr. Commissioner:

In accordance with the Rules of Procedure for Conducting Hearings Before the Commissioner of Conservation of the State of Louisiana, application is hereby made on behalf of **Swift Energy Operating, LLC** for the calling of a public hearing, after legal notice, to consider evidence relative to the issuance of an order pertaining to the following matters relating to the 6750' Zone, Reservoir A, Lake Washington Field, Plaquemines Parish, Louisiana:

1. To grant an exception to the spacing provisions of Statewide Order No. 29-E and to create a single drilling and production unit of approximately 23 acres for the 6750' Zone, Reservoir A designated as the 6750' RA SUA, Lake Washington Field, Plaquemines Parish, Louisiana, all as shown more particularly on the attached plat.
2. To establish rules and regulations governing the exploration for and production of oil and gas from the said unit.
3. To force pool and integrate all separately owned tracts, mineral leases and other property interests within the unit so created, with each tract sharing in unit production on a surface acreage basis of participation.
4. To designate a unit operator and unit well for the unit created herein.

5. To consider such other matters relating to the subject reservoir as may be appropriate and justified by the evidence presented at the public hearing.

The 6750' Zone, Reservoir A in the Lake Washington Field, Plaquemines Parish, Louisiana is hereby defined as that oil and gas bearing zone encountered between the measured depths of 7,355 feet and 8,499 feet (electrical log measurements) (-6598' and -7266' subsea) in the Swift Energy Operating, LLC-Cockrell-Moran No. 398 Well, located in Section 26, Township 20 South, Range 26 East, Plaquemines Parish, Louisiana.

In accordance with the Rules of Procedure for Conducting Hearings Before the Commissioner of Conservation of the State of Louisiana, the Commissioner of Conservation, the District Manager of the Lafayette District of the Office of Conservation and all interested owners, represented parties and interested parties known to the applicant after a reasonable search were notified in writing in the pre-application notice dated December 11, 2008 that a conference to discuss the proposed application was tentatively scheduled for 10:00 a.m. on Monday, January 5, 2009. It was stated at that time that this conference would be held only if a request to confer were received by the undersigned within ten (10) calendar days after the date of the pre-application notice. No requests to confer were received either in writing or by telephone and, in accordance with the Rules of Procedure, the tentatively scheduled conference **WILL NOT BE HELD**.


