

**LEGAL NOTICE**

**STATE OF LOUISIANA, OFFICE OF CONSERVATION, BATON ROUGE, LOUISIANA.**

In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Hearing Room, 1<sup>st</sup> Floor, LaSalle Building, 617 North 3<sup>rd</sup> Street, Baton Rouge, Louisiana, at 9:00 a.m. on **TUESDAY, JANUARY 27, 2009**, upon the application of **ENERGEN RESOURCES CORPORATION**.

At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the **Hosston A Zone and the Hosston B Zone**, in the Sailes Field, Bienville Parish, Louisiana.

1. To authorize Applicant to drill, designate and utilize one (1) additional alternate unit well each for HOSS A SUS and HOSS B SUS and for HOSS A SUQQ and HOSS B SUQQ, at the locations shown on the plats submitted with the application.
2. To approve an exception to the spacing provisions of Office of Conservation Order No. 408-A, effective August 1, 1970, for either of the above described wells the location of which does not comply with the spacing provisions of said Order.
3. To find that each of the above described wells is necessary to efficiently and economically drain a portion of the Hosston A and B Zones, underlying the units on which it is proposed to be drilled which cannot be efficiently and economically drained by any existing well on such units.
4. To authorize the downhole combination of production from the Hosston A Zone and the Hosston B Zone in the wellbore of any well located on HOSS A SUQQ and HOSS B SUQQ in which the ownership interests in these units are identical.
5. To consider such other matters as may be pertinent.

The Hosston A Zone was defined in Order No. 408-A, effective August 1, 1970.

The Hosston B Zone was defined in Order No. 408-A-1, effective February 18, 1971.

Plats are available for inspection in the Office of Conservation in **Baton Rouge and Shreveport**, Louisiana.
