Dear Commissioner Welsh:

Application is hereby made on behalf of **ENERGYQUEST II, LLC** for the calling of a public hearing, after legal notice, to consider evidence relative to the issuance of an order pertaining to the following matters:

1. To establish rules and regulations and to create a single drilling and production unit for the exploration for and production of oil and gas from the Miocene 3A-1 Zone, Reservoir A, in the North Crowley Field, Acadia Parish, Louisiana, said proposed unit designated MIO 3A-1 RA SUA, as shown on the plat attached hereto and made a part hereof.
2. To force pool and integrate all separately owned tracts, mineral leases and other property interests within the proposed unit with each tract sharing in unit production on a surface acreage basis of participation.
3. To designate Energyquest II, LLC as operator of the proposed unit.
4. To designate its J. B. Stakes No. 36 Well as unit well for the proposed unit.
5. To provide that any wells drilled to the Miocene 3A-1 Zone, Reservoir A, in North Crowley Field, within or outside of the unit created herein, should be located no closer than 50 feet from any unit boundary with no minimum distances between wells.
6. To provide that the Commissioner of Conservation should be authorized to reclassify the reservoir by supplemental order without the necessity of a public hearing if the producing characteristics of the reservoir change and evidence to justify such reclassification is submitted to and accepted by the Commissioner of Conservation.

7. To consider such others matters as may be pertinent.

The Miocene 3A-1 Zone, Reservoir A, in the North Crowley Field, is hereby defined as being that oil and gas bearing zone encountered between the depths of 4,820 feet and 4,975 feet (electrical log measurements) in the Energyquest II, LLC – J. B. Stakes No. 36 Well, located in Section 33, Township 8 South, Range 1 East, Acadia Parish, Louisiana.


