Dear Commissioner Welch,

Application is hereby made on behalf of Union Gas Operating Company, Inc. to the Commissioner of Conservation for the calling of a public hearing, after legal notice, to consider evidence relative to the issuance of orders pertaining to the following matters relating to the Frio Zone, Reservoir A, in the Carpenters Bridge Field, Allen Parish, Louisiana:

1. To establish rules and regulations and to create a single drilling and production unit for the exploration for and production of gas and condensate from the Frio Zone, Reservoir A in the Carpenters Bridge Field, Allen Parish, Louisiana, said proposed unit designated F RA SUA, as shown on the plat attached hereto and made a part hereof.
2. To force pool and integrate all separately owned tracts, mineral leases and other property interests within the proposed unit with each tract sharing in unit production on a surface acreage basis of participation.
3. To designate Union Gas Operating Company as operator of the proposed F RA SUA.
4. To provide that any wells drilled to the Frio Zone, Reservoir A shall be located in accordance with the spacing provisions of Statewide Order No. 29-E.
5. To provide that the Commissioner may reclassify the reservoirs by Supplemental Orders without the necessity of a public hearing should such reclassification be warranted, based on evidence furnished by the Commissioner.
6. To discuss any other matters that may be pertinent to this application.


The Frio Zone, Reservoir A, in the Carpenters Bridge Field is hereby defined as being that gas and condensate bearing sand encountered between the depths of 6,520' and 7,340' electric log measured depths in the Wewoka Exploration Co., Lake Charles Naval Shores No. 1 Well, located in Section 18, Township 5 South, Range 5 West, Allen Parish, Louisiana.

In compliance with the Rules of Procedure, a pre-application notice was given, but no request for a conference was received, and therefore, none was held. No opposition is expected at the hearing.

There are attached hereto and made a part hereof, plats outlining the proposed unit and the conference attendance list. 
