On behalf of CHESAPEAKE OPERATING, INC., application is hereby made for a public hearing to receive evidence concerning the issuance of an order pertaining to the following matters relating to the Haynesville Zone, Reservoir A, in the Johnson Branch Field, Caddo Parish, Louisiana:

1. To permit Applicant to drill, designate and utilize a unit well for HA RA SUW, at the location shown on the plat attached hereto, in exception to the spacing provisions of Office of Conservation Order No. 994-D, effective July 10, 2007, in exception to the spacing provisions of Office of Conservation Order No. 994-D, effective July 10, 2007 and 270-MM, effective June 19, 2007 ;
2. To explicitly find that the proposed unit well is in the interest of conservation and is necessary to drain a portion of the Haynesville Zone, Reservoir A, underlying HA RA SUW, which cannot be efficiently and economically drained by any existing well in such unit;
3. To consider such other matters as may be appropriate and justified by the evidence presented at the hearing.

The Haynesville Zone, Reservoir A, in the Johnson Branch Field, Caddo Parish, Louisiana was defined in Office of Conservation Order No. 994-D, effective July 10, 2007 .


