Dear Mr. Commissioner:

Application is hereby made on behalf of **Kindee Oil & Gas Louisiana, LLC** for the calling of a public hearing, after ten days legal notice, to consider evidence relative to the issuance of an order pertaining to the following matters regarding the Miogypsinoides Zone, Reservoir B SUA, Laurel Ridge Field, Iberville and Ascension Parishes, Louisiana, for which rules and regulations were established and a drilling and production unit was created by the Office of Conservation Order No. 131-S-1, effective January 11, 2005.

1. To permit applicant, Kindee Oil & Gas Louisiana, LLC to drill, designate and utilize the Kindee Oil & Gas Louisiana, LLC-Jumonville No. 2 Well as an additional alternate unit well for the MIO RB SUA, such well to be at the location shown on the plat attached hereto and made a part hereof;
2. To make a specific finding that such proposed alternate unit well is necessary to effectively and efficiently drain a portion of the MIO RB SUA which cannot be efficiently and economically drained by any other well within the unit.
3. To grant a single unit allowable for the MIO RB SUA and to permit the operator of the unit to produce said unit allowables from the unit well, the alternate unit well, the proposed alternate unit well, or from any combination at its option;

4. To confirm Kindee Oil & Gas Louisiana, LLC as the operator of the MIO RB SUA.
5. To find that, except to the extent contrary in the order granted by the Commissioner of Conservation in connection with the hearing held on this application, the provisions of Office of Conservation No. 131-S-1, shall remain in full force and effect, and
6. To consider such other matters pertinent to this application as shown by the evidence presented at the hearing held on this matter.

The Miogyptinoides Zone, Reservoir B, Laurel Ridge Field, Iberville and Ascension Parishes, Louisiana was previously defined in Office of Conservation Order No. 131-S-1, effective January 11, 2005.




