Proposed Additional Haynesville Zone, Reservoir A Unit
Caspiana Field
DeSoto Parish, Louisiana

Application is hereby made on behalf of **EXCO PRODUCTION COMPANY, L.P.**, (Applicant), to the Commissioner of Conservation for a public hearing to consider evidence relative to the issuance of an Order pertaining to the following matters relating to the Haynesville Zone, Reservoir A, Caspiana Field, DeSoto Parish, Louisiana:

1. To create one (1) additional 640 +/- acre drilling and production unit for the production of gas and condensate from the Haynesville Zone, Reservoir A, such unit to consist of Section 32, Township 14 North, Range 12 West, and to be designated HA RA SU92, in the Caspiana Field, DeSoto Parish, Louisiana, such unit shown on the attached plat and made a part hereof.
2. To define the Haynesville Zone, Reservoir A, **INSOFAR AND ONLY INSOFAR**, as to the proposed Haynesville Zone, Reservoir A Unit for Section 32, Township 14 North, Range 12 West is concerned, as that gas and condensate producing interval encountered from 10,217 feet and 12,055 feet (electric log measurements) in the EXCO Production Company, LP – Lee 19 No. 1 Well, located in Section 19, Township 14 North, Range 12 West, DeSoto Parish, Louisiana.
3. To force pool and integrate all separately owned tracts, mineral leases and other properties within the proposed units in accordance with Section 10, Title 30, of the Louisiana Revised Statutes of 1950, with each tract to share in the unit production on a surface acreage basis of participation.
4. To designate a unit operator and unit well, at an exceptional location, for the Haynesville Zone, Reservoir A, for the unit being proposed herein.
5. To extend the provisions of the 191-H Series of Office of Conservation Orders and other pertinent Statewide Orders to the proposed unit for the Haynesville Zone, Reservoir A, and applicable Statewide Orders to the unit being proposed herein, except as they may be in conflict herewith.

The Haynesville Zone, Reservoir A, in the Caspiana Field, Caddo and Desoto Parishes, Louisiana was originally defined in Office of Conservation Order No. 191-H, effective August 28, 2007, and is being proposed to be redefined for and only insofar as to the HA RA SU92 being proposed herein in accordance with Number 2 hereof.
