APPLICATION FOR PUBLIC HEARING

Dear Sir:

WSF, Inc. hereby makes application pursuant to the revised rules of procedure for a public hearing to consider evidence relating to the following matters pertaining to the Haynesville Zone, Reservoir A, in the Elm Grove Field, Bossier Parish, Louisiana:

1. To create one additional drilling and production unit for the exploration for and production of gas and condensate from the Haynesville Zone, Reservoir A, in the Elm Grove Field, Bossier Parish, Louisiana, to be designated HA RA SU76, as shown outlined on the plat attached hereto and made a part hereof;
2. To define the Haynesville Zone, Reservoir A, in the Elm Grove Field, INSOFAR AS HA RA SU76 IS CONCERNED, as the stratigraphic equivalent of that gas and condensate bearing interval occurring between the depths of 9,650 feet and 11,426 feet (electric log measurements) in the KCS Resources, Inc. - Elm Grove Plantation No. 15 Well (Serial No. 229326) located in Section 9, Township 16 North, Range 11 West, Bossier Parish, Louisiana;
3. To force pool and integrate all of the separately owned tracts, mineral leases and other property interests located within the proposed unit in accordance with Section 10, Title 30, of the Louisiana Revised Statutes of 1950, with each tract sharing in unit production on a surface acreage basis of participation;
4. To designate a unit well and unit operator, as appropriate;
5. To provide that with respect to horizontal wells drilled to the Haynesville Zone, Reservoir A, in or to serve the proposed unit, where the horizontal lateral portion of the well is cased and cemented back above the top of the Haynesville Zone, Reservoir A, the distance to any unit boundary and offset wells in adjacent units will be calculated based

on the distance to the nearest perforation in the well, and not based on the penetration point or terminus;

6. To extend to the additional unit, except to the extent inconsistent herewith, the provisions of Office of Conservation Order No. 361-L, effective July 29, 2008, as amended and supplemented by the 361-L Series of Orders, and of all applicable Statewide Orders; and
7. To consider and cover such other matters as the Commissioner of Conservation may deem appropriate and necessary under the circumstances.



A pre-application conference relative to this matter was requested and held on Wednesday, May 13, 2009. Those who attended the conference are identified on the attached list. Bill Fleming and Craig Barclay explained the unitization plan on behalf of the Applicant. There were questions asked and answered. There were concerns expressed on behalf of some parties concerning operational issues. There were no specific concerns expressed about the proposed unitization plan. One party, Ms. Judith Lombardino, requested a conference on behalf of herself and her family but was unable to attend the conference as scheduled. A subsequent conference will be held with Ms. Lombardino at a time mutually convenient for all concerned. The rights of Ms. Lombardino and those persons for whom she serves as designated representative were reserved.

The list of parties attached to the copies of this application being sent to the Office of Conservation includes the names of all Interested Owners, Represented Parties and Interested Parties known to Applicant after a diligent search. A copy of this application, with plat attached, is being sent to each such party. Pursuant to Office of Conservation regulations, the list of parties is being furnished only to the Commissioner of Conservation and to the District Manager of the Shreveport District of the Office of Conservation; however, the list of parties will be provided to any person requesting a copy of it. Enclosed with the copy of this application being sent to the Commissioner of Conservation is a check for the appropriate application fee.


