Dear Sir:

On behalf of CLAYTON WILLIAMS ENERGY, INC., application is hereby made for a public hearing to receive evidence concerning the issuance of an order pertaining to the following matters relating to the Lower Cotton Valley Formation, Reservoir A, in the Terryville Field, Lincoln Parish, Louisiana:

1. To permit the Applicant to drill, designate and utilize nine (9) additional alternate unit wells for LCV RA SUPP, at the locations shown on the plat attached hereto, six (6) of which are in exception to the well spacing provisions of the 370-B Series of Office of Conservation Orders.
2. To explicitly find that the proposed alternate unit wells are in the interest of conservation and are necessary to drain a portion of the Lower Cotton Valley Formation, Reservoir A, in the Terryville Field, underlying LCV RA SUPP, which cannot be efficiently and economically drained by any existing well in such unit.
3. To consider such other matters as may be appropriate and justified by the evidence presented at the hearing.

The Lower Cotton Valley Formation, Reservoir A, in the Terryville Field, Lincoln Parish, Louisiana, was redefined in Office of Conservation Order No. 370-B-148, effective April 22, 2008, INsofar AS LCV RA SUPP is concerned.

The Rules of Procedure of the Commissioner of Conservation pertaining to the Pre-Application Notice requirements, are not applicable to the hearing requested herein, which requires legal notice of only ten (10) days.

Pertinent data concerning the intended application will be made available for inspection at the offices of the undersigned. Any person wishing to inspect such data should call the undersigned at (318) 221-6858 during normal business hours or write the undersigned at the above address in order to arrange a date and time for such inspection. A copy of any such pertinent data can be obtained at the expense of the requesting party.






TOWNSHIP 19 NORTH, RANGES 3 & 4 WEST,
