

**LEGAL NOTICE**

**STATE OF LOUISIANA, OFFICE OF CONSERVATION, BATON ROUGE, LOUISIANA.**

In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Hearing Room, 1<sup>st</sup> Floor, LaSalle Building, 617 North 3<sup>rd</sup> Street, Baton Rouge, Louisiana, at 9:00 a.m. on **TUESDAY, JULY 14, 2009**, upon the application of **QUESTAR EXPLORATION AND PRODUCTION COMPANY**.

At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the **Haynesville Zone, Reservoir A**, in the Thorn Lake Field, Red River Parish, Louisiana.

1. To authorize Questar Exploration and Production Company to drill, designate and utilize three (3) alternate unit wells for HA RA SUL at the locations and in the general manner shown on the plat submitted with the application, or within one hundred feet of the paths and bottom hole locations shown, provided that there are no perforations in any wellbore closer than 330 feet to any unit boundary.
2. To establish that the proposed alternate unit wells are necessary to efficiently and economically drain a portion of the Haynesville Zone, Reservoir A, underlying HA RA SUL.
3. To authorize the unit allowable for this unit to be recovered from the existing unit well or the proposed alternate unit wells, or any combination thereof, at the discretion of the operator.
4. To consider such other matters as may be pertinent.

The Haynesville Zone, Reservoir A, was defined in Office of Conservation Order No. 1145-B, effective July 15, 2008.

A plat is available for inspection in the Office of Conservation in **Baton Rouge and Shreveport**, Louisiana.
