LEGAL NOTICE

STATE OF LOUISIANA, OFFICE OF CONSERVATION, BATON ROUGE, LOUISIANA.

In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Hearing Room, 1st Floor, LaSalle Building, 617 North 3rd Street, Baton Rouge, Louisiana, at 9:00 a.m. on **TUESDAY, JULY 14, 2009**, upon the application of **QUESTAR EXPLORATION AND PRODUCTION COMPANY**.

At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the **Hosston Formation, Reservoir B, and the Cotton Valley Formation, Reservoir B**, in the Woodardville Field, Bienville Parish, Louisiana.

1. To authorize the applicant to drill, designate and utilize an additional alternate unit well on each of HOSS RB SUE and CV RB SUE at the locations shown on the plat submitted with the application, which location is in lieu of the location 502 feet FEL of Section 20, Township 15 North, Range 9 West, and 1950 feet FSL of HOSS RB SUE and CV RB SUE, which location was approved by Office of Conservation Order Nos. 990-C-116 and 990-B-118, both of which orders were effective August 19, 2008.
2. To determine there is the need for an additional alternate unit well on each of these units to efficiently and economically recover hydrocarbons underlying the units that cannot otherwise be recovered by existing wells located on these units.
3. To grant such exceptions to the well spacing provisions of Order No. 990-C, effective February 1, 2006, with respect to the Hosston Formation, Reservoir B, and Order No. 990-B, effective September 13, 2005, with respect to the Cotton Valley Formation, Reservoir B, as may be necessary with respect to the proposed alternate unit wells.
4. To authorize the unit allowable for these units to be recovered from the existing well on the units, the proposed alternate unit wells, or from any combination thereof, at the discretion of the operator.
5. To consider such other matters as may be pertinent.

The Hosston Formation, Reservoir B was defined in Order No. 990-C, effective February 1, 2006, and was further defined by Order No. 990-C-8, effective January 9, 2007.

The Cotton Valley Formation, Reservoir B was defined in Order No. 990-B, effective September 13, 2005, and was redefined as to specific units in subsequent orders.

A plat is available for inspection in the Office of Conservation in **Baton Rouge and Shreveport**, Louisiana.
