Dear Sir:

Application is hereby made on behalf of Hilcorp Energy Company to the Commissioner of Conservation for the calling of a public hearing, after legal notice, to consider evidence relative to the issuance of an order pertaining to the following matters relating to the 6C Sand, Reservoir I, in the West Bay Field, Plaquemines Parish, Louisiana.

1. To dissolve the 6C RI SUA, as established by Office of Conservation Order No. 396-J-3, effective November 28, 2000, in the West Bay Field, and simultaneously therewith, to create a revised unit for the exploration for and production of gas and condensate from the 6C Sand, Reservoir I, in the West Bay Field, Plaquemines Parish, Louisiana.
2. To force pool and integrate all separately owned tracts, mineral leases and other property interests within the unit so created.
3. To designate Hilcorp Energy Company as operator of the 6C RI SUA.
4. To designate the Hilcorp Energy Company - Tambour Corp. et al A No. 1 Well as the unit well and the Hilcorp Energy Company - Tambour Corp. et al A No. 3 Well as the alternate unit well.
5. To provide that the operator of the 6C RI SUA, can produce the unit allowable from the unit well, the alternate unit well or any combination thereof.
6. To provide that the 6C Sand, Reservoir I, should be exempt from the spacing provisions of Statewide Order No. 29-E.
7. To provide that the Commissioner may reclassify the 6C Sand, Reservoir I, by supplemental order and without the necessity of a public hearing should such reclassification be warranted, based on evidence furnished the Commissioner.

8. To discuss any other matters that may be pertinent to this application.

The 6C Sand, Reservoir I, in the West Bay Field, Plaquemines Parish, Louisiana, was fully defined in Office of Conservation Order No. 396-J-3, effective November 28, 2000.

In addition to furnishing the legal notice to all Interested Parties, the applicant will provide for POSTING of the legal notice of the hearing and unit plat in a prominent place in the area of the West Bay Field, Plaquemines Parish, Louisiana, and will cause the legal notice of the hearing to be PUBLISHED in a newspaper of general circulation published in the vicinity of the West Bay Field, Plaquemines Parish, Louisiana, at least fifteen (15) days before the hearing date.

Any pertinent data relating to the subject application can be obtained, **AT THE COST OF THE REQUESTING PARTY**, from Cambe Geological Services, 6300 Westpark, Suite 400, Houston, Texas 77057 (713-659-8363).

In compliance with the Rules of Procedure, a preapplication notice was given, but no request for a conference was received, and therefore, none was held.

There are attached hereto and made a part hereof a plat outlining the proposed unit and a list of the names and addresses of the Interested Owners, Represented Parties, and Interested Parties to whom this application is being sent. Pursuant to the Revised Rules of Procedure, such list of parties and proposed unit plat (being the same plat attached to the June 24, 2009 notice) are being furnished **ONLY** to the Commissioner of Conservation and to the District Manager of the Lafayette District of the Office of Conservation. However, said plat and the list of parties will be provided to any party requesting copies. A reasonable effort was made to ascertain the names and addresses of all Interested Owners, Represented Parties and Interested Parties.

Finally, there is enclosed our check on behalf of the applicant, Hilcorp Energy Company, in the sum of \$755.00 payable to the Office of Conservation and representing the required hearing application fee.


