APPLICATION FOR PUBLIC HEARING

Dear Sir:

Petrohawk Operating Company hereby makes application pursuant to the revised rules of procedure for a public hearing to consider evidence relating to the following matters pertaining to the Haynesville Zone, Reservoir B, in the Red River-Bull Bayou Field, Red River Parish, Louisiana:

1. To create an additional drilling and production unit for the exploration for and production of gas and condensate from the Haynesville Zone, Reservoir B, in the Red River-Bull Bayou Field, Red River Parish, Louisiana, to be designated HA RB SU63, as shown outlined on the plat attached hereto and made a part hereof;
2. To force pool and integrate all of the separately owned tracts, mineral leases and other property interests located within the proposed unit in accordance with Section 10, Title 30, of the Louisiana Revised Statutes of 1950, with each tract sharing in unit production on a surface acreage basis of participation;
3. To designate a unit well and unit operator, as appropriate;
4. To confirm that with respect to horizontal wells drilled to the Haynesville Zone, Reservoir B, in or to serve the proposed unit, where the horizontal lateral portion of the well is cased and cemented back above the top of the Haynesville Zone, Reservoir B, the distance to any unit boundary will be calculated based on the distance to the nearest perforation in the well, and not based on the penetration point or terminus;
5. Except to the extent contrary herewith, to extend the provisions of Office of Conservation Order No. 109-X-4, effective November 6, 2008, and all applicable Statewide Orders, to the proposed units; and

6. To consider and cover such other matters as the Commissioner of Conservation may deem appropriate and necessary under the circumstances.

The Haynesville Zone, Reservoir B, in the Red River-Bull Bayou Field, Red River and DeSoto Parishes, Louisiana, was defined in Office of Conservation Order No. 109-X-4, effective November 6, 2008.





:PROPOSED HAYNESVILLE ZONE, RESERVOIR B SAND UNIT




:EXISTING HAYNESVILLE ZONE SAND UNITS
