Dear Commissioner Welsh:

Application is hereby made on behalf of **ENERGY PRODUCTION CORPORATION** for the calling of a public hearing, after ten (10) days legal notice, to consider evidence relative to the issuance of orders concerning the following matters pertaining to the **19,900' Tuscaloosa Zone, Reservoir A**, in the **Moore-Sams Field**, Pointe Coupee Parish, Louisiana, for which rules and regulations were established and two (2) drilling and production units were created by Office of Conservation Order No. 1063-C, effective August 7, 2007, to-wit:

1. To permit the applicant, Energy Production Corporation, to drill, designate and utilize its Energy Production Corporation – H.L.Bonaventure, et al 51 No. 1 Well as the substitute unit well for the unit designated 19900 TUSC RA SUA at the location shown on the plat attached hereto, which is in compliance with the spacing provisions of the Office of Conservation Order No. 1063-C, effective August 7, 2007;

2. To confirm Energy Production Corporation as the operator of the 19900 TUSC RA SUA;
3. Except to the extent contrary herewith, to continue in full force and effect all pertinent provisions of Office of Conservation Order No. 1063-C, effective August 7, 2007, and all applicable Statewide Orders; and
4. To consider such other matters as may be pertinent to this application as shown by the evidence presented at the public hearing.

The 19,900' Tuscaloosa Zone, Reservoir A, in the Moore-Sams Field, was previously defined in Office of Conservation Order No. 1063-C, effective August 7, 2007.


The existing unit well has been recompleted into the 18,100' Tuscaloosa Sand. There being no existing well completed within the unit that can drain the reservoir, the proposed substitute unit well is necessary to drain a portion of the unit which cannot be drained by any existing unit well in the unit.

There is attached hereto and made a part hereof a plat which outlines the 19900 TUSC RA SUA, and reflects the location of the current unit well and the proposed substitute unit well. There is also a list of the names and addresses of the interested parties to whom this unitization proposal is being sent. Pursuant to the Revised Rules of Procedure, such list of parties is being furnished ONLY to the Commissioner of Conservation. However, the list of parties will be provided to any party requesting a copy of it. A reasonable effort was made to ascertain the names and addresses of all Interested Owners, Represented Parties and Interested Parties.

Finally, enclosed herein is our check in the amount of \$755.00 made payable to the Office of Conservation in payment of the required hearing application fee.


