Dear Commissioner Welsh:

Application is hereby made on behalf of **SAMSON CONTOUR ENERGY E & P, LLC.**, for the calling of a public hearing, after thirty (30) days legal notice, to consider evidence relative to the issuance of Orders pertaining to the following matters related to the **Yegua Zone, Reservoir A** and **Yegua Zone, Reservoir B**, in the **Edgerly Field**, Calcasieu Parish, Louisiana, to-wit:

1. To establish rules and regulations and create a single drilling and production unit for the exploration for and production of gas and condensate, for each reservoir, such units to be designated Y RA SUA and Y RB SUA;
2. To force pool and integrate all separately owned tracts, mineral leases and other property interests within the proposed units, with each tract sharing in unit production on a surface acreage basis of participation;

3. To designate Samson Contour Energy E&P, LLC. as operator of the proposed units, and to designate a unit well for each of the proposed units;
4. To provide that any future wells drilled to the Yegua Zone, Reservoir A, or the Yegua Zone, Reservoir B, within or outside of the proposed units, should be located in accordance with the spacing provisions of Statewide Order 29-E;
5. To provide that the Commissioner of Conservation should be authorized to reclassify the reservoirs, by supplemental order without the necessity of a public hearing if the producing characteristics of the reservoirs change and evidence to justify such reclassification is submitted to and accepted by the Commissioner of Conservation; and
6. To consider such other matters as may be appropriate and justified by the evidence presented at the hearing.

The Yegua Zone, Reservoirs A and B in the Egerly Field, Calcasieu Parish, Louisiana, is hereby defined as being that gas and condensate bearing zone encountered between the depths of 12,925 feet and 16,450 feet (electrical log measurements) in the B.H.P. Petroleum - Glover No. 1 Well located in Section 10, Township 10 South, Range 11 West, Calcasieu Parish, Louisiana. The top of the Yegua Zone is further defined at a depth of 10, 740 feet (electrical log measurements) in the Samedan-LaBokay No. 1 Well, located in Section 2, Township 9 South, Range 12 West, Calcasieu Parish, Louisiana.

The pre-application conference tentatively scheduled for September 1, 2010, **WILL NOT BE HELD**, as it was not requested within the delays provided for by the Rules of Procedure; therefore, no opposition to this Application at the hearing is anticipated.

However, the list of parties will be provided to any party requesting a copy of it. A reasonable effort was made to ascertain the names and addresses of all Interested Owners, Represented Parties and Interested Parties.




