Chevron U.S.A. Inc. (Chevron) requests the calling of a public hearing, after due legal notice, to consider the following matters pertaining to the Upper 4525 Foot Zone, Reservoir J, in the Bay Marchand Block 2 Field, Lafourche Parish, Louisiana.

1. To establish rules and regulations governing the exploration for and production of oil and from the above sand.
2. To establish a single drilling and production unit for the above sand.
3. To force pool and integrate all separately owned tracts and mineral leases and other mineral interests within the unit.
4. To designate Chevron U.S.A. Inc. as operator of the U 4525 RJ SUA.
5. To designate Chevron's SL 1367 Well No. O-6 ST1 as the unit well for the U 4525 RJ SUA.
6. To provide that any future replacement and/or alternate wells for said unit shall be exempt from the spacing provisions of Statewide Order No. 29-E.
7. To provide for future reclassification of the reservoir without the necessity of a public hearing if such reclassification becomes necessary due to a change in production characteristics.
8. To consider such other matters as the Commissioner may deem pertinent.

The Upper 4525 Foot Zone, Reservoir J, in the Bay Marchand Block 2 Field is hereby defined as being that oil and gas bearing sand encountered between the electric log depths of 6,420 (-6,212 TVD SS) feet and 6,445 (-6,230 TVD SS) feet in the Chevron – SL 1367 Well No. O-6 ST1, located in Block 3, Lafourche Parish, Louisiana.

Chevron will provide for the advertisement of the legal notice in a newspaper of general circulation in the vicinity of the Bay Marchand Block 2 Field, and also will post the legal notice and unit plat in a prominent place in the area of the field. Chevron will also mail a copy of said legal notice and unit plat to Interested Owners, Represented Parties and to Interested Parties.




