Dear Sir:

Application is hereby made on behalf of Hilcorp Energy Company for the calling of a public hearing, after ten (10) days legal notice, to consider evidence relative to the issuance of an order pertaining to the following matters relating to the 4 RM SUA, located in the West Bay Field, Plaquemines Parish, Louisiana, created by Office of Conservation Order No. 396-L-2, effective November 28, 2000.

1. To designate the Hilcorp Energy Company - Tambour Corp. A No. 3 Well, located in Section 29, Township 22 South, Range 31 East, in the West Bay Field, Plaquemines Parish, Louisiana, as a substitute unit well.
2. Except as may be in conflict with the provisions hereof, the provisions of the Office of Conservation Order No. 396-L-2 shall remain in full force and effect.
3. To consider such other matters as may be pertinent to this application.

The present unit well designated by Order No. 396-L-2, the Tambour Corp. A No. 2 Well, ceased to produce from the 4 Sand in July, 2002, therefore, the designation of the Tambour Corp. A No. 3 Well as a substitute unit well is necessary and in the interest of conservation to efficiently and economically drain a portion of the 4 RM SUA which cannot be efficiently and economically drained by any existing well within such unit.

The 4 Sand, Reservoir M, in the West Bay Field, Plaquemines Parish, Louisiana, was fully defined in Office of Conservation Order No. 396-L-2, effective November 28, 2000.

There is attached hereto and made a part hereof a plat identifying the subject unit created by Conservation Order No. 396-L-2, along with the location of the proposed substitute unit well. Pursuant to the Revised Rules of Procedure, a list of names and addresses of the Interested Owners, Interested Parties and Represented Parties to whom this application is being sent is being furnished only to the Commissioner of Conservation and to the District Manager of the Lafayette District of the Office of Conservation. However, the list will be provided to any party requesting a copy. A diligent effort was made to ascertain the names and addresses of all Interested Owners, Interested Parties and Represented Parties as required by the Revised Rules of Procedure.

Finally there is enclosed our check on behalf of the applicant, Hilcorp Energy Company, in the sum of \$755.00 payable to the Office of Conservation and representing the required hearing application fee.


