Dear Commissioner Welsh:

Application is hereby made on behalf of **ENERGY PRODUCTION CORPORATION** for the calling of a public hearing, after ten (10) days legal notice, to consider evidence relative to the issuance of an order pertaining to the following matters related to the **18,100' Tuscaloosa Sand, Reservoir A**, in the **Moore-Sams Field**, Pointe Coupee Parish, Louisiana, for which rules and regulations were established and a pattern of drilling and producing units was created by Office of Conservation Order No. 1063, effective May 1, 1979, as amended and supplemented by the 1063-A Series of Orders, to-wit:

1. To permit the applicant, Energy Production Corporation, to drill, designate, and utilize the Energy Production Corporation – Joel Deville, et al No. 2 Well as an alternate unit well for the unit designated 18100 TUSC RA SUM at the location shown on the plat attached hereto and made a part hereof, which is in compliance with the spacing provisions of Office of Conservation Order No. 1063, effective May 1, 1979;

2. To find that the proposed alternate unit well is necessary to economically and efficiently drain reserves from the 18100 TUSC RA SUM which cannot be economically and efficiently recovered by any existing wells within such unit;
3. To permit the unit operator, Energy Production Corporation, to produce the unit allowable for the 18100 TUSC RA SUM from the unit well, the alternate unit well, or both, at its discretion;
4. Except to the extent contrary herewith, to continue in full force and effect the provisions of Office of Conservation Order No. 1063, effective May 1, 1979, as amended and supplemented by the 1063-A Series of Orders, and all applicable Statewide Orders; and
5. To consider such other matters as may be pertinent to this application as shown by the evidence presented at the public hearing.

The 18,100' Tuscaloosa Sand, Reservoir A, in the Moore-Sams Field, Pointe Coupee Parish, Louisiana, was previously defined in Office of Conservation Order No. 1063, effective May 1, 1979, and was redefined by Office of Conservation Order No. 1063-A-12, effective August 7, 2007.



A reasonable effort was made to ascertain the names and addresses of all Interested Owners, Represented Parties and Interested Parties.

Finally, there is enclosed our check in the sum of \$755.00 payable to the Office of Conservation, representing the required hearing application fee.

Your receipt of this Application does not require you to take any action. It is meant to notify you of these proceedings so that you have the opportunity to participate if you so desire.


