EL PASO E&P COMPANY, L.P. ("Applicant"), hereby respectfully applies for a public hearing to consider evidence relative to the issuance of Orders pertaining to the following matters relating to the Hosston A Zone and to the Hosston B Zone in the West Bryceland Field, Bienville Parish, Louisiana:

1. To authorize Applicant to drill, designate and utilize an additional alternate unit well for HOSS A SUJ and for HOSS B SUJ at the location shown on the attached plats, in exception to the spacing provisions of Office of Conservation Order No. 241-A, effective December 1, 1966.
2. To find that the proposed alternate unit well is necessary to efficiently and economically drain a portion of the Hosston A and B Zones underlying these units which cannot be efficiently and economically drained by any existing well on such units.
3. To consider such other matters as may be appropriate and justified by the evidence presented at the hearing.

The Hosston A Zone in West Bryceland Field, Bienville Parish, Louisiana, was defined in Office of Conservation Order No. 241-A, effective December 1, 1966. The Hosston B Zone in West Bryceland Field, Bienville Parish, Louisiana, was defined in Office of Conservation Order No. 241-A-8, effective March 16, 1972.


As provided by the Revised Rules of Procedure, the subject matter of this application does not require the issuance of a pre-application notice; therefore, no such notice has been issued.

Applicant will provide for posting of a copy of the Legal Notice of this hearing and the enclosed plats at a prominent place in the area affected and will cause publication of the Legal Notice in a newspaper published in the general area of West Bryceland Field, all in accordance with the Revised Rules of Procedure. Furthermore, Applicant will mail a copy of the Legal Notice to all Interested Owners, Represented Parties and Interested Parties promptly upon receipt of the Legal Notice from the Commissioner.


