Haynesville Zone, Reservoir A, BETHANY-
LONGSTREET FIELD, DeSoto Parish, Louisiana.

Dear Sir:

CORONADO ENERGY E&P COMPANY, L.L.C. ("Applicant"), hereby respectfully applies for a public hearing to consider evidence relative to the issuance of Orders pertaining to the following matters relating to the Haynesville Zone, Reservoir A, in the Bethany-Longstreet Field, DeSoto Parish, Louisiana:

1. To authorize Applicant to drill, designate and utilize three (3) horizontal wells as alternate unit wells for HA RA SUV, three (3) horizontal wells as alternate unit wells for HA RA SUW, three (3) horizontal wells as alternate unit wells for HA RA SUX and three (3) horizontal wells as alternate unit wells for HA RA SUEE, all at the locations shown on the attached plat.
2. To provide that where the horizontal portion of a well is cased and cemented back above the top of the Haynesville Zone, Reservoir A, the distance to any unit boundary and any offset well(s) shall be calculated based on the distance to the nearest perforation in the well and not based on the penetration point or terminus.
3. To find that each of the proposed alternate unit wells is necessary to efficiently and economically drain a portion of the Haynesville Zone, Reservoir A, underlying the unit on which it is proposed to be drilled which cannot be efficiently and economically drained by any existing well on such unit.
4. To permit the operator of HA RA SUV, HA RA SUW, HA RA SUX and HA RA SUEE to produce the allowables assigned to these units from either the unit well, from any alternate unit well, or from any combination of such wells, at the option of the Operator.
5. To consider such other matters as may be appropriate and justified by the evidence presented at the hearing.

The Haynesville Zone, Reservoir A, in the Bethany-Longstreet Field, DeSoto Parish, Louisiana, was initially defined in Office of Conservation Order No. 289-R, effective April 1, 2008,

was redefined as to HA RA SUV, HA RA SUW and HA RA SUX by Office of Conservation Order No. 289-R-5, effective July 22, 2008, and was redefined as to HA RA SUEE by Office of Conservation Order No. 289-R-34, effective July 21, 2009.

Any pertinent data concerning this application will be available for inspection at the offices of Louis Gilbert & Associates, Inc., 3636 North Causeway Boulevard, Suite 204, Metairie, Louisiana 70002-7216. Any person wishing to inspect any such data should call Mr. Louis Gilbert at (504) 834-8112 during normal business hours in order to arrange a date and time for such inspection. A copy of any such pertinent data which is not otherwise available from the Office of Conservation can be obtained from Applicant at the expense of the requesting party.


As provided by the Revised Rules of Procedure, the subject matter of this application does not require the issuance of a pre-application notice; therefore, no such notice has been issued.

Applicant will provide for posting of a copy of the Legal Notice of this hearing, and the enclosed plat, at a prominent place in the area affected and will cause publication of the Legal Notice in a newspaper published in the general area of Bethany-Longstreet Field, all in accordance with the Revised Rules of Procedure. Furthermore, Applicant will mail a copy of the Legal Notice to all Interested Owners, Represented Parties and Interested Parties promptly upon receipt of the Legal Notice from the Commissioner.

Finally, enclosed herewith is our check payable to the Office of Conservation covering the application fee.


