LEGAL NOTICE

STATE OF LOUISIANA, OFFICE OF CONSERVATION, BATON ROUGE, LOUISIANA.

In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Hearing Room, 1st Floor, LaSalle Building, 617 North 3rd Street, Baton Rouge, Louisiana, at 9:00 a.m. on **TUESDAY, MARCH 2, 2010**, upon the application of **PETROHAWK OPERATING COMPANY**.

At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the **Haynesville Zone, Reservoir A**, in the Elm Grove Field, Webster Parish, Louisiana.

1. To create two (2) additional drilling and production units for the exploration for and production of gas and condensate from the Haynesville Zone, Reservoir A, to be designated HA RA SU111 and HA RA SU112.
2. To force pool and integrate all of the separately owned tracts, mineral leases and other property interests located within the proposed units in accordance with Section 10, Title 30, of the Louisiana Revised Statutes of 1950, with each tract sharing in unit production on a surface acreage basis of participation.
3. To redefine the Haynesville Zone, Reservoir A, INsofar AND ONLY INsofar as HA RA SU111 and HA RA SU112, are concerned, as the stratigraphic equivalent of that gas and condensate bearing zone occurring between the depths of 9,650' and 11,426' (electrical log measurements) in the KCS Resources, LLC.-Elm Grove Plantation No. 15 Well, located in Section 9, Township 16 North, Range 11 West.
4. To designate unit wells and unit operators, as appropriate.
5. To provide that with respect to horizontal wells drilled to the Haynesville Zone, Reservoir A, in or to serve the proposed units, where the horizontal lateral portion of the well is cased and cemented back above the top of the Haynesville Zone, Reservoir A, the distance to any unit boundary or offset well will be calculated based on the distance to the nearest perforation in the well, and not based on the penetration point or terminus.
6. To extend to the proposed units, except to the extent inconsistent herewith, the provisions of Office of Conservation Order No. 361-L, effective July 29, 2008, as amended and supplemented by the 361-L Series of Orders, and of all applicable Statewide Orders.
7. To consider such other matters as may be pertinent.

The Haynesville Zone, Reservoir A was previously defined in Order No. 361-L, effective July 29, 2008, and is to be redefined INsofar AND ONLY INsofar as HA RA SU111 and HA RA SU112 are concerned as provided herein.
