2. That with respect to the proposed horizontal well to be drilled to the Haynesville Zone, Reservoir A, within or to serve the HA RA SUW, where the horizontal portion of the well is cased and cemented back above the top of the Haynesville Zone, Reservoir A, the distance to any unit boundary and any offset well(s) should be calculated based on the distance to the nearest perforations in the well and not based on the penetration point.

Application is hereby made on behalf of **EXCO OPERATING COMPANY, LP**, (Applicant), to the Commissioner of Conservation for a Public Hearing to consider evidence relative to the issuance of an Order pertaining to the following matters relating to the Haynesville Zone, Reservoir A, DeSoto Parish, Louisiana:

1. To permit the Applicant to drill, designate and utilize seven (7) horizontal laterals for HA RA SUW as alternate unit wells for the production of gas and condensate from the Haynesville Zone, Reservoir A, Kingston Field, DeSoto Parish, Louisiana, such units and proposed horizontal laterals shown on the attached plats and being made a part hereof.
2. That with respect to the proposed horizontal well to be drilled to the Lower Cotton Valley Zone, Reservoir A, within or to serve the HA RA SUW, where the horizontal portion of the well is cased and cemented back above the top of the Haynesville Zone, Reservoir A, the distance to any unit boundary and any offset well(s) should be calculated based on the distance to the nearest perforations in the well and not based on the penetration point.
3. To find that additional alternate unit wells are needed on the HA RA SUW to assist in draining a portion of the Haynesville Zone, Reservoir A, that cannot be drained by any other well located within each unit.

4. To permit the unit operator to produce the assigned unit allowable from the unit well, the alternate unit well or from a combination of all wells, at its discretion.
5. To consider and cover such other matters as the Commissioner of Conservation may deem pertinent and appropriate.

The Haynesville Zone, Reservoir A, was defined in Office of Conservation Order No. 376-D, effective November 18, 2008.


