EL PASO E&P COMPANY, L.P. ("Applicant"), hereby respectfully applies for a public hearing to consider evidence relative to the issuance of an Order pertaining to the following matters relating to the Hosston A Zone in the Sibley Field, Webster Parish, Louisiana:

1. To authorize Applicant to complete, designate and utilize its Plunkett A No. 1 Well as an additional alternate unit well for HOSS A SUQ, said well being located as shown on the attached plat, in exception to the spacing provisions of Office of Conservation Order No. 148-J, effective February 1, 1972.

2. To find that the proposed alternate unit well is necessary to efficiently and economically drain a portion of the Hosston A Zone underlying HOSS A SUQ which cannot be efficiently and economically drained by any existing well on the unit.

3. To consider such other matters as may be appropriate and justified by the evidence presented at the hearing.

The Hosston A Zone in Sibley Field, Webster Parish, Louisiana, was defined in Office of Conservation Order No. 148-J, effective February 1, 1972.

Any pertinent data concerning this application will be available for inspection at the offices of Louis Gilbert & Associates, Inc., 3636 North Causeway Boulevard, Suite 204, Metairie, Louisiana 70002-7216. inspection. A copy of any such data which is not otherwise available at the Office of Conservation can be obtained from Mr. Gilbert at the expense of the requesting party.


As provided by the Revised Rules of Procedure, the subject matter of this application does not require the issuance of a pre-application notice; therefore, no such notice has been issued.

Furthermore, Applicant will mail a copy of the Legal Notice to all Interested Owners, Represented Parties and Interested Parties promptly upon receipt of the Legal Notice from the Commissioner.




