Application is hereby made on behalf of **HARTER OIL COMPANY**, (Applicant), to the Commissioner of Conservation for a Public Hearing to consider evidence relative to the issuance of an Order pertaining to the following matters relating to the Wilcox D Zone, Reservoir A, Olla Field, LaSalle Parish, Louisiana:

1. To permit the Applicant to designate and utilize an existing well bore, the Harter Oil Company – Nugent C No. A-8 Well, as the unit well for the production of oil and gas and/or gas and condensate for the Wilcox D Zone, Reservoir A, in the unit designated WX D RA SU169, Olla Field, LaSalle Parish, Louisiana, such unit and well, shown on the attached plat and being made a part hereof, in exception to the spacing provisions of Office of Conservation Order No. 1235-B, effective January 1, 1986.
2. To find that a unit well, at the location shown on the attached plat, will efficiently and effectively drain the Wilcox D Zone, Reservoir A, in the unit designated WX D RA SU169 that cannot be drained by any other well located within the unit.
3. To consider and cover such other matters as the Commissioner of Conservation may deem pertinent and appropriate.

Attached hereto is our check, made payable to the Office of Conservation, to cover the applicable hearing fee.


