

**LEGAL NOTICE**

**STATE OF LOUISIANA, OFFICE OF CONSERVATION, BATON ROUGE, LOUISIANA.**

In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Hearing Room, 1<sup>st</sup> Floor, LaSalle Building, 617 North 3<sup>rd</sup> Street, Baton Rouge, Louisiana, at 9:00 a.m. on **TUESDAY, APRIL 6, 2010**, upon the application of **EXCO OPERATING COMPANY, LP.**

At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the **Cotton Valley Formation, Reservoir A**, in the Kelleys Field, Jackson Parish, Louisiana.

1. To redefine the Cotton Valley Formation, Reservoir A, insofar and only insofar as the CV RA SUC, CV RA SUD, CV RA SUE and CV RA SUF are concerned, as being that gas and condensate bearing zone encountered between the depths of 9,820' and 13,900' (electrical log measurements) as seen in the Exco Production Company, LP-Hodde, et al 14 No. 1 Well located in Section 14, Township 17 North, Range 2 West.
2. To redefine the Cotton Valley Formation, Reservoir A, insofar and only insofar as the CV RA SUP, is concerned, as being that gas and condensate bearing zone encountered between the depths of 10,074' and 13,900' (electrical log measurements) as seen in the Exco Production Company, LP-Hodde, et al 14 No. 1 Well located in Section 14, Township 17 North, Range 2 West.
3. Except to the extent contrary herewith, to continue in full force and effect the provisions of Office of Conservation Order No. 633-D, effective August 20, 1980, as amended and supplemented by the 633-D Series of Orders, the units created thereby, and applicable Statewide Orders.
4. To consider such other matters as may be pertinent.

The Cotton Valley Formation, Reservoir A was defined in Order No. 633-D-3, effective February 5, 1982, was most recently redefined as to certain units in Order No. 633-D-9, effective October 6, 2009, and is hereby redefined insofar and only insofar as the CV RA SUC, CV RA SUD, CV RA SUE, CV RA SUF and CV RA SUP are concerned, in accordance with Items 1 and 2 hereof.

A plat is available for inspection in the Office of Conservation in **Baton Rouge and Shreveport**, Louisiana.
