APPLICATION FOR PUBLIC HEARING

Dear Sir:

Petrohawk Operating Company hereby makes application pursuant to the revised rules of procedure for a public hearing to consider evidence relating to the following matters pertaining to the Haynesville Zone, Reservoir A, in the Caspiana Field, DeSoto Parish, Louisiana:

1. To create one additional drilling and production unit for the exploration for and production of gas and condensate from the Haynesville Zone, Reservoir A, in the Caspiana Field, DeSoto Parish, Louisiana, to be designated HA RA SU152, as shown outlined on the plat attached hereto;
2. To force pool and integrate all of the separately owned tracts, mineral leases and other property interests located within the proposed unit in accordance with Section 10, Title 30, of the Louisiana Revised Statutes of 1950, with each tract sharing in unit production on a surface acreage basis of participation;
3. To redefine the Haynesville Zone, Reservoir A, INsofar AND ONLY AS HA RA SU152 is concerned, as the stratigraphic equivalent of that gas and condensate bearing zone occurring between the depths of 9,720 feet and 11,690 feet (electrical log measurements) in the KCS Resources, LLC. - Hunt Plywood No. 11 Well located in Section 36, Township 15 North, Range 13 West, DeSoto Parish, Louisiana;
4. To designate a unit well and unit operator, as appropriate;
5. To provide that with respect to horizontal wells drilled to the Haynesville Zone, Reservoir A, in or to serve the proposed unit, where the horizontal lateral portion of the well is cased and cemented back above the top of the Haynesville Zone, Reservoir A, the distance to any unit boundary or offset well will be calculated based on the distance to the nearest perforation in the well, and not based on the penetration point or terminus;
6. To extend to the proposed unit, except to the extent inconsistent herewith, the pertinent provisions of Office of Conservation Order No. 191-H, effective August 28, 2007, as

amended and supplemented by the 191-H Series of Orders including Order No. 191-H-14, effective August 26, 2008, and all applicable Statewide Orders, and

7. To consider and cover such other matters as the Commissioner of Conservation may deem appropriate and necessary under the circumstances.

The Haynesville Zone, Reservoir A, in the Caspiana Field, was initially defined in Office of Conservation Order No. 191-H, effective August 28, 2007, and is to be redefined INsofar AND ONLY INsofar as HA RA SU152 is concerned as provided herein.




