On behalf of CHESAPEAKE OPERATING, INC., application is hereby made for a public hearing to receive evidence concerning the issuance of an order pertaining to the following matters relating to the Haynesville Zone, Reservoir A, in the Greenwood-Waskom Field, Caddo Parish, Louisiana.

1. To create one (1) additional drilling and production unit (to be designated as HA RA SU82) for the exploration for and production of gas and condensate from the Haynesville Zone, Reservoir A, in the Greenwood-Waskom Field, Caddo Parish, Louisiana, as shown on the plat attached hereto;
2. To force pool and unitize all separately owned tracts, mineral leases, and other property interests within the proposed unit, with allocation of production to the tracts within such unit to be on the basis of surface acreage;
3. With respect to future horizontal wells drilled to the Haynesville Zone, Reservoir A, within or to serve the proposed unit, where the horizontal portion of the well is cased and cemented back above the top of the Haynesville Zone, Reservoir A, the distance to any unit boundary and any offset well(s) will be calculated based on the distance to the nearest perforation in the well, and not based on the penetration point or terminus;
4. To redefine the Haynesville Zone, Reservoir A, in the Greenwood-Waskom Field, INsofar AND ONLY INsofar as to the proposed HA RA SU82, as being that gas and condensate bearing zone encountered between the depths of 9,828 feet and 11,145 feet (electrical log measurements) in the Encore Operating Louisiana, L.L.C. (formerly Greystone Oil & Gas, L.L.P.) - Querbes No. 2 Well located in 29, Township 16 North, Range 16 West, Caddo Parish, Louisiana;

5. To provide that any future wells drilled to the Haynesville Zone, Reservoir A, within or outside of the unit created herein, should be located no closer than 330 feet to any unit line and no closer than 660 feet to any well completed in, drilling to or for which a permit has been granted to drill to the Haynesville Zone, Reservoir A, in the Greenwood-Waskom Field, Caddo Parish, Louisiana;
6. Except to the extent in conflict herewith, to extend the provisions of the Office of Conservation Order No. 270-MM, effective June 19, 2007, as amended and supplemented by the 270-MM Series of Orders, to the unit created hereby;
7. To consider such other matters and issue such orders as may be appropriate and justified by the evidence presented at the hearing.

The Haynesville Zone, Reservoir A, in the Greenwood-Waskom Field, was initially defined in Office of Conservation Order No. 270-MM, effective June 19, 2007, but shall be redefined as set forth above.

Pertinent data regarding this application will be available for inspection at the offices of Blanchard, Walker, O'Quin & Roberts, Chase Tower, 400 Texas Street, Suite 1400, Shreveport, Louisiana 71101. Any person wishing to inspect such data should call Mr. Wm. Timothy Allen III at (318) 221-6858, during normal business hours, or write Mr. Allen at the above address in order to arrange a time and date for such inspection. Copies of such pertinent data can be obtained AT THE EXPENSE OF THE REQUESTING PARTY.

A list of the names and addresses of all Interested Owners, Represented Parties and Interested Parties (as defined in the Revised Rules of Procedure) is attached hereto, and a copy of this notice, with the annexed plat, is being sent to each of such persons. A reasonable effort has been made to determine that the enclosed list includes all of the persons to whom this notice must be sent under the Rules of Procedure. Pursuant to the Revised Rules of Procedure, such list of parties is being furnished ONLY to the Commissioner of Conservation and to the District Manager of the Shreveport District of the Office of Conservation. However, the list of parties will be provided to any party requesting a copy of it.

A Pre-Application Conference was held at the Petroleum Club of Shreveport on February 22, 2010. In addition to the Applicant's representatives, said conference was attended by the parties shown on the attached attendance list. Following a presentation by the Applicant's representatives of the geological and other bases for the Applicant's proposal, a general discussion ensued prior to adjournment. It is anticipated that the hearing will be uncontested.

A check in the amount of \$755.00 made payable to the Commissioner of Conservation is enclosed herewith as the statutory fee for holding the requested hearing.

This application is being filed in duplicate, and a copy hereof is being sent to Mr. James C. Broussard, Shreveport District Manager of the Office of Conservation, to each Interested Owner,

Represented Party and Interested Party whose name is shown on the attached list and the Pre-Application Conference Attendees.

***You may have received this Hearing Application even though your property may not be included in the proposed unit, because the Revised Rules of Procedure require us to attempt to also notify everyone owning an interest in the area "proximate to" the proposed unit.***


