

LEGAL NOTICE

STATE OF LOUISIANA, OFFICE OF CONSERVATION, BATON ROUGE, LOUISIANA.

In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Hearing Room, 1st Floor, LaSalle Building, 617 North 3rd Street, Baton Rouge, Louisiana, at 9:00 a.m. on **TUESDAY, APRIL 13, 2010**, upon the application of **COMSTOCK OIL & GAS-LOUISIANA, LLC**.

At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the **Haynesville Zone, Reservoir A**, in the Converse Field, Sabine Parish, Louisiana.

1. To create six (6) additional drilling and production units for the exploration for and production of gas and condensate from the Haynesville Zone, Reservoir A.
2. To force pool and integrate all separately owned tracts, mineral leases and other property interests within each of the proposed units, with allocation of production to the tracts within such units to be on the basis of surface acreage.
3. To provide that with respect to future horizontal wells drilled to the Haynesville Zone, Reservoir A, within or to serve the proposed units, where the horizontal portion of the well is cased and cemented back above the top of the Haynesville Zone, Reservoir A, the distance to any unit boundary and any offset well(s) will be calculated based on the distance to the nearest perforation in the well, and not based on the penetration point or terminus.
4. To designate Comstock Oil & Gas-Louisiana, LLC as unit operator and to designate unit wells for the proposed HA RA SURR thru HA RA SUUU, HA RA SU55 and HA RA SU56, if appropriate.
5. Except to the extent contrary herewith, to extend provisions of Office of Conservation Order No. 501-G, effective April 7, 2009, as amended and supplemented by the 501-G Series of Orders, to the proposed units.
6. To consider such other matters as may be pertinent.

The Haynesville Zone, Reservoir A was defined in Order No. 501-G, effective April 7, 2009.

A plat is available for inspection in the Office of Conservation in **Baton Rouge** and **Shreveport**, Louisiana.
