Dear Commissioner Welsh:

Application is hereby made on behalf of **CHESAPEAKE OPERATING, INC.**, for the calling of a public hearing, after thirty (30) days legal notice, to consider evidence relative to the issuance of Orders pertaining to the following matters related to the **Haynesville Zone, Reservoir A**, in the **Longwood Field**, Caddo Parish, Louisiana, for which rules and regulations were established and a pattern of drilling and production units was created by Office of Conservation Order No. 123-K, effective June 17, 2008, as amended and supplemented by the 123-K Series of Orders, to-wit:

1. To create one (1) additional drilling and production unit for the exploration for and production of gas and condensate from the Haynesville Zone, Reservoir A, such unit to be designated HA RA SUBB;
2. To redefine the Haynesville Zone, Reservoir A, INSOFAR AND ONLY INSOFAR as the proposed unit referenced herein is concerned, in accordance with the DEFINITION section hereof;

3. To force pool and integrate all separately owned tracts, mineral leases and other property interests within the proposed unit, with each tract sharing in unit production on a surface acreage basis of participation;
4. To designate Chesapeake Operating, Inc. as the operator of, and a unit well for the proposed unit, if appropriate;
5. To provide that with respect to horizontal wells drilled to the Haynesville Zone, Reservoir A, within or to serve the proposed unit, where the horizontal portion of the well is cased and cemented back above the top of the Haynesville Zone, Reservoir A, the distance to any unit boundary and any offset well(s) should be calculated based on the distance to the nearest perforation in the well, and not based on the penetration point or terminus;
6. To extend to the proposed unit, to the extent not inconsistent herewith, all pertinent provisions of Office of Conservation Order No. 123-K, effective June 17, 2008, as amended and supplemented by the 123-K Series of Orders, and all applicable Statewide Orders; and
7. To consider such other matters as may be appropriate and justified by the evidence presented at the hearing.

The Haynesville Zone, Reservoir A, in the Longwood Field, Caddo Parish, Louisiana, was previously defined in Office of Conservation Order No. 123-K, effective June 17, 2008, and is hereby redefined, **INSOFAR AND ONLY INSOFAR** as the proposed unit referenced herein is concerned, as being that gas and condensate bearing zone encountered between the depths of 9,702 feet and 11,149 feet (electrical log measurements) in the Exco - Wages 12 No. 1 Well, located in Section 12, Township 18 North, Range 16 West, Caddo Parish, Louisiana.

The pre-application conference tentatively scheduled for March 17, 2010, **WILL NOT BE HELD**, as it was not requested within the delays provided for by the Rules of Procedure; therefore, no opposition to this Application at the hearing is anticipated.

There is attached hereto and made a part hereof a plat outlining the proposed unit and a list of the names and addresses of the interested parties to whom this unitization proposal is being sent. Pursuant to the Revised Rules of Procedure, such list of parties is being furnished **ONLY** to the Commissioner of Conservation and to the District Manager of the Shreveport District of the Office of Conservation. 


