**Re: APPLICATION FOR PUBLIC HEARING**

Proposed Alternate Unit Wells

Application is hereby made on behalf of **EXCO OPERATING COMPANY, L.P.**, (Applicant), to the Commissioner of Conservation for a Public Hearing to consider evidence relative to the issuance of an Order pertaining to the following matters relating to the Haynesville Zone, Reservoir A, Caspiana Field, DeSoto Parish, Louisiana:

1. To permit the Applicant to drill, designate and utilize four (4) alternate unit wells for the production of gas and condensate for the Haynesville Zone, Reservoir A, in the unit designated HA RA SU145, Caspiana Field, DeSoto Parish, Louisiana, such unit and wells, shown on the attached plat and being made a part hereof.
2. To find that alternate unit wells are necessary, at the locations shown on the attached plat, to assist in draining a portion of the Haynesville Zone, Reservoir A, in the unit designated HA RA SU145 that cannot be drained by any other well located within the unit.
3. To find that with respect to horizontal well(s) to be drilled to the Haynesville Zone, Reservoir A, within or to serve the HA RA SU145, where the horizontal portion of the well is cased and cemented back above the top of the Haynesville Zone, Reservoir A, the distance to any unit boundary and any offset well(s) shall be calculated based on the distance from the nearest perforations in the well and not based on the penetration or terminus point.
4. To permit the unit operator to produce the assigned unit allowable from the unit well, the alternate unit wells or from a combination of all wells, at its discretion.
5. To consider and cover such other matters as the Commissioner of Conservation may deem pertinent and appropriate.

The Haynesville Zone, Reservoir A, in the Caspiana Field, DeSoto Parish, Louisiana, was initially defined in Office of Conservation Order No. 191-H, effective August 27, 2007, and was redefined in Office of Conservation Order No. 191-H-73, effective January 12, 2010, insofar as it concerns the HA RA SU145.
