Application is hereby made on behalf of **Gordy Oil Company** for the calling of a public hearing, after ten (10) days legal notice, to consider evidence relative to the issuance of an order pertaining to the following matters relating to the Nodosaria Blanpiedi Zone, Reservoir A, SUA, located in the Turps Field, Beauregard Parish, Louisiana, for which rules and regulations were established and a drilling and production unit was created for the exploration for and production of oil and gas by Office of Conservation Order No. 1435-G, effective January 13, 2009.

1. To permit the applicant to designate and utilize its E. Dubose, et al No. 2 Well as an alternate unit well for the NB RA SUA, said well to be at the location shown on the plat attached hereto.

2. To permit the operator to produce the unit allowable from the existing unit well, the proposed alternate unit well, or both at its option.

3. To confirm the unit created by Office of Conservation Order 1435-G, effective January 13, 2009.

4. Except to the extent herein designated, to continue in full force and effect the provisions of Office of Conservation Order No. 1435-G.

5. To consider such other matters as may be pertinent to this application.

The Nodosaria Blanpeidi Zone, in the Turps Field, Beauregard Parish, Louisiana, was fully defined in Office of Conservation Order No. 1435-G, effective January 13, 2009.

The designation of the proposed alternate unit well would permit efficient and economic recovery of the hydrocarbons underlying said unit and is needed to satisfy the market demand for oil and gas from the field.

There is attached hereto and made a part hereof a plat showing the applicant's proposal. However, the list will be provided to any party requesting a copy. A diligent effort was made to ascertain the names and addresses of all Interested Owners, Interested Parties and Represented Parties as required by the Revised Rules of Procedure.

Finally there is enclosed our check on behalf of the applicant, Gordy Oil Company, in the sum of \$755.00 payable to the Office of Conservation and representing the required hearing application fee.
