Proposed Alternate Unit Well
Haynesville Zone, Reservoir A
HA RA SUR
Caspiana Field
Caddo and DeSoto Parishes, Louisiana

Application is hereby made on behalf of **CAMTERRA RESOURCES, INC., L.P.**, (Applicant), to the Commissioner of Conservation for a Public Hearing to consider evidence relative to the issuance of an Order pertaining to the following matters relating to the Haynesville Zone, Reservoir A, Caspiana Field, Caddo and DeSoto Parishes, Louisiana:

1. To permit the Applicant to drill, designate and utilize an alternate unit well for the production of gas and condensate for the Haynesville Zone, Reservoir A, in the unit designate HA RA SUR, Caspiana Field, Caddo and DeSoto Parishes, Louisiana, such unit and well, shown on the attached plat and being made a part hereof.
2. To find that an alternate unit well is necessary, at the location shown on the attached plat, to assist in draining a portion of the Haynesville Zone, Reservoir A, in the unit designated HA RA SUR, that cannot be drained by any other well located within the unit.
3. To find that with respect to horizontal well(s) to be drilled to the Haynesville Zone, Reservoir A, within or to serve the HA RA SUR, where the horizontal portion of the well is cased and cemented back above the top of the Haynesville Zone, Reservoir A, the distance to any unit boundary and any offset well(s) shall be calculated based on the distance from the nearest perforations in the well and not based on the penetration or terminus point.
4. To permit the unit operator to produce the assigned unit allowable from the unit well, the alternate unit well or from a combination of all wells, at its discretion.
5. To consider and cover such other matters as the Commissioner of Conservation may deem pertinent and appropriate.

The Haynesville Zone, Reservoir A, in the Caspiana Field, DeSoto Parish, Louisiana, was initially defined in Office of Conservation Order No. 191-H, effective August 27, 2007, and was redefined in Office of Conservation Order No. 191-H-12, effective December 2, 2008, for and only insofar as it concerns the HA RA.


