Dear Mr. Commissioner:

Application is hereby made on behalf of **Swift Energy Operating, LLC** for the calling of a public hearing, after ten days legal notice, to consider evidence relative to the issuance of an order pertaining to the following matters regarding the 4400' Zone, Reservoir A SUA, Lake Washington Field, Plaquemines Parish, Louisiana, for which rules and regulations were established and a drilling and production unit was created by the Office of Conservation Order No. 149-JJJ, effective February 10, 2004, as amended and supplemented.

1. To permit applicant, Swift Energy Operating, LLC to drill, designate and utilize the Swift Energy Operating, LLC-Cockrell-Moran No. 411 Well as an additional alternate unit well for the 4400' RA SUA, such well to be at the location shown on the plat attached hereto and made a part hereof;
2. To make a specific finding that such proposed alternate unit well is necessary to effectively and efficiently drain a portion of the 4400' RA SUA which cannot be efficiently and economically drained by any other well within the unit.
3. To grant a single unit allowable for the 4400' RA SUA and to permit the operator of the unit to produce said unit allowables from the unit well, the existing alternate unit wells, the proposed alternate unit well, or from any combination at its option;
4. To confirm Swift Energy Operating, LLC as the operator of the 4400' RA SUA.

5. To find that, except to the extent contrary in the order granted by the Commissioner of Conservation in connection with the hearing held on this application, the provisions of Office of Conservation No. 149-JJJ, effective February 10, 2004, as amended and supplemented, shall remain in full force and effect, and
6. To consider such other matters pertinent to this application as shown by the evidence presented at the hearing held on this matter.

The 4400' Zone, Reservoir B, Lake Washington Field, Plaquemines Parish, Louisiana was previously defined in Office of Conservation Order No. 149-JJJ, effective February 10, 2004.




4400' RB SUA


