Application is hereby made on behalf of GRAND GULF ENERGY, INC. to the Commissioner of Conservation for the calling of a public hearing, after legal notice, to consider evidence relative to the issuance of an order pertaining to the following matters relating to the L Tex W-Big Hum Zone, Reservoir A, in the Napoleonville Field, Assumption Parish, Louisiana.

1. To establish rules and regulations governing the exploration for and production of gas and condensate from the L Tex W-Big Hum Zone, Reservoir A, in the Napoleonville Field, Assumption Parish, Louisiana.

2. To create a single drilling and production unit for this zone and to force pool and integrate all separately owned tracts, mineral leases and other property interests within the unit so created.

3. To designate a unit operator and a unit well for the unit so created as may be appropriate.

4. To provide that the L Tex W-Big Hum Zone, Reservoir A, should be exempt from the spacing provisions of Statewide Order No. 29-E.

5. To provide that the Commissioner may reclassify the reservoir by supplemental order and without the necessity of a public hearing should such reclassification be warranted, based on evidence furnished the Commissioner.

6. To discuss any other matters that may be pertinent to this application.

The L Tex W-Big Hum Zone, in the Napoleonville Field, Assumption Parish, Louisiana, is hereby defined as being that gas and condensate bearing zone encountered between the depths of 4890' to 5192' (electrical log measurements) in the Patrick Petroleum Company - Clifton Land Corp. No.1 Well (S.N. 138813), located in Section 45, Township 12 South, Range 13 East, Assumption Parish, Louisiana.

In addition to furnishing the legal notice to all Interested Parties, the applicant will provide for POSTING of the legal notice of the hearing and unit plat in a prominent place in the area of the Napoleonville Field, Assumption Parish, Louisiana, and will cause the legal notice of the hearing to be PUBLISHED in a newspaper of general circulation published in the vicinity of the Napoleonville Field, Assumption Parish, Louisiana, at least fifteen (15) days before the hearing date.

Any pertinent data relating to the subject application can be obtained, **AT THE COST OF THE REQUESTING PARTY**, from Cambe Geological Services, Inc., 6300 Westpark, Suite 400, Houston, Texas 77057 (713-659-8363).

In compliance with the Rules of Procedure, a preapplication notice was given, but no request for a conference was received, and therefore, none was held.

There are attached hereto and made a part hereof a plat outlining the proposed unit and a list of the names and addresses of the Interested Owners, Represented Parties, and Interested Parties to whom this application is being sent. Pursuant to the Revised Rules of Procedure, such list of parties and proposed unit plat (being the same plat attached to the May 27, 2010 notice) are being furnished **ONLY** to the Commissioner of Conservation and to the District Manager of the Lafayette District of the Office of Conservation. However, said plat and the list of parties will be provided to any party requesting copies. A reasonable effort was made to ascertain the names and addresses of all Interested Owners, Represented Parties and Interested Parties.

Finally, there is enclosed our check on behalf of the applicant, Grand Gulf Energy, Inc., in the sum of \$755.00 payable to the Office of Conservation and representing the required hearing application fee.
