Dear Sir:

Application is hereby made on behalf of Hilcorp Energy Company for the calling of a public hearing, after ten (10) days legal notice, to consider evidence relative to the issuance of an order pertaining to the following matters relating to the MA 7 RA SUB, located in the Garden City Field, St. Mary Parish, Louisiana, created by Office of Conservation Order No. 450-A-3, effective January 1, 1967.

1. To designate the Hilcorp Energy Company - Maryland No. 12 Well, located in Section 19, Township 15 South, Range 10 East, in the Garden City Field, St. Mary Parish, Louisiana, as a substitute unit well.
2. To find that a tolerance of fifty (50) feet for the location of the proposed substitute unit well is necessary to account for the possible variance between the proposed location and the "as drilled" location.
3. To consider such other matters as may be pertinent to this application.

The designation of the well as a substitute unit well is necessary and in the interest of conservation to efficiently and economically drain a portion of the MA 7 RA SUB which cannot be efficiently and economically drained by any existing well within such unit. The present unit well, the Maryland No. 8 Well, never produced from the MA 7 RA SUB and has been shut-in since August 1, 2008. The alternate unit well, the Maryland No. 6 Well, was plugged and abandoned on December 23, 2000.

The MA 7 Sand, Reservoir A, in the Garden City Field, St. Mary Parish, Louisiana, was fully defined in Office of Conservation Order No. 450-A-1, effective August 1, 1962.

There is attached hereto and made a part hereof a plat identifying the subject unit created by Conservation Order No. 450-A-3, along with the location of the proposed substitute unit well. Pursuant to the Revised Rules of Procedure, a list of names and addresses of the Interested Owners, Interested Parties and Represented Parties to whom this application is being sent is being furnished only to the Commissioner of Conservation and to the District Manager of the Lafayette District of the Office of Conservation. However, the list will be provided to any party requesting a copy. A diligent effort was made to ascertain the names and addresses of all Interested Owners, Interested Parties and Represented Parties as required by the Revised Rules of Procedure.

Finally there is enclosed our check on behalf of the applicant, Hilcorp Energy Company, in the sum of \$755.00 payable to the Office of Conservation and representing the required hearing application fee.


