XTO ENERGY, INC. ("Applicant"), hereby respectfully applies for a public hearing to consider evidence relative to the issuance of an Order pertaining to the following matters relating to the Smackover C Zone, Reservoir B, in the North Shongaloo-Red Rock Field, Webster Parish, Louisiana:

1. To authorize Applicant to drill, designate and utilize two (2) alternate unit wells for SMK C RB SUG at the locations shown on the attached plat.
2. To find that each of the proposed alternate unit wells is necessary to efficiently and economically drain a portion of the Smackover C Zone, Reservoir B, underlying SMK C RB SUG which cannot be efficiently and economically drained by any existing well on the unit.
3. To permit the operator of SMK C RB SUG to produce the allowable assigned to this unit from either the unit well, from any alternate unit well, or from any combination of such wells, at the option of the operator.
4. To consider such other matters as may be pertinent to these proposals.

The Smackover C Zone, Reservoir B, in the North Shongaloo-Red Rock Field, was defined in Office of Conservation Order No. 104-H-4, effective June 24, 1986.

Any pertinent data concerning this application will be available for inspection at the offices of Louis Gilbert & Associates, Inc., 3636 N. Causeway Blvd., Suite 204, Metairie, Louisiana 70002-7216. Any person wishing to inspect any such data should call Mr. Louis Gilbert at (504) 834-8112 during normal business hours in order to arrange a date and time for such inspection. A copy of any such data which is not otherwise available at the Office of Conservation can be obtained from Applicant at the expense of the requesting party.


As provided by the Revised Rules of Procedure, the subject matter of this application does not require the issuance of a pre-application notice; therefore, no such notice has been issued.

Furthermore, Applicant will mail a copy of the Legal Notice to all Interested Owners, Represented Parties and Interested Parties promptly upon receipt of the Legal Notice from the Commissioner.


