Dear Commissioner Welsh:

Application is hereby made on behalf of Exxon Mobil Corporation to the Commissioner of Conservation for the calling of a public hearing, after legal notice, pertaining to the following matters relative to the Haynesville Zone, Reservoir A, Converse Field, Sabine Parish, Louisiana:

1. To create three (3) additional drilling and production units for the exploration for and production of gas and condensate from the Haynesville Zone, Reservoir A, designated as HA RA SU 82, HA RA SU 83 and the HA RA SU 84, as shown on the plat attached hereto;
2. To force pool and integrate all separately owned tracts, mineral leases and other property interests within the unit so created on a surface acreage basis of participation;
3. To designate a unit operator of, and unit wells for, the proposed units as may be appropriate;
4. Except to the extent they may be inconsistent herewith, to extend to the additional units the pertinent provisions of Office of Conservation Order No. 501-G, effective April 7, 2009, as amended and supplemented by the 501-G series of orders, and all applicable statewide Orders;
5. To provide that with respect to horizontal wells drilled to the Haynesville Zone, Reservoir A, in or to serve the proposed units, where the horizontal

lateral portion of the well is cased and cemented back above the top of the Haynesville Zone, Reservoir A, the distance to any unit boundary and any offset well(s) will be calculated based on the distance to the nearest perforation in the well, and not based on the penetration point or terminus; and;

6. To consider such other matters as may be pertinent to the Haynesville Zone, Reservoir A.

The Haynesville Zone, Reservoir A, in the Converse Field, Sabine Parish, Louisiana, was defined in Office of Conservation Order No. 501-G, effective April 7, 2009.

No request for the pre-application conference was received, and accordingly IT WILL NOT BE HELD. No opposition is expected at the hearing on this matter.


In addition to furnishing the legal notice to all Interested Owners, Represented Parties and Interested Parties, the applicant will provide for posting of the legal notice and unit plat in a prominent place in the area of Converse Field. Additionally, the legal notice will be published in a newspaper of general circulation in the vicinity of Converse Field at least fifteen (15) days before the hearing date.




