Application is hereby made on behalf of Array Operating, LLC for the calling of a public hearing, after ten (10) days legal notice, to consider evidence relative to the issuance of an Order pertaining to the following matters relating to change of operator regarding a certain well in the Bolivina Mexicana 3 Zone, Reservoir L, Broussard Field, Lafayette Parish, Louisiana:

1. To remove the existing operator, Reef Exploration LP, and to designate the applicant as operator of the following well: the Reef Exploration - J Montesano et al No. 1 Well (Serial No. 229215), in Broussard Field, Lafayette Parish, Louisiana.
2. To consider such other matters as may be pertinent.

The applicant, Array Operating, LLC, has requested that the existing operator file Form MD-10-R-AO to amend operator designation of the aforementioned well; however, to date Reef


