

LEGAL NOTICE

STATE OF LOUISIANA, OFFICE OF CONSERVATION, BATON ROUGE, LOUISIANA.

In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Hearing Room, 1st Floor, LaSalle Building, 617 North 3rd Street, Baton Rouge, Louisiana, at 9:00 a.m. on **THURSDAY, AUGUST 26, 2010**, upon the application of **ANADARKO PETROLEUM CORPORATION**.

At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the **Hosston Formation, Reservoir A, Cotton Valley Formation, Reservoir A and Haynesville Zone, Reservoir A**, in the Alpha Field, Natchitoches Parish, Louisiana.

1. To create four (4) additional drilling and production units for the exploration for and production of gas and condensate from each of the following intervals: Hosston Formation, Reservoir A, Cotton Valley Formation, Reservoir A and Haynesville Zone, Reservoir A, said units designated as shown on the plats submitted with the application.
2. To force pool and integrate all separately owned tracts, mineral leases and other property interests within the proposed units with each tract sharing in unit production on a surface acreage basis of participation.
3. To extend to the proposed additional units for each interval all pertinent provisions of the following respective orders as appropriate: Office of Conservation Order No. 1158, effective September 16, 1981, as amended and supplemented by the 1158-A Series of Orders, for the Hosston Formation, Reservoir A, Order No. 1158-B, effective August 25, 2009, for the Cotton Valley Formation, Reservoir A; and Order No. 1158-C, effective August 25, 2009 for the Haynesville Zone, Reservoir A, and all applicable Statewide Orders.
4. To consider such other matters as may be pertinent.

The Hosston Formation, Reservoir A was defined in Order No. 1158, effective September 16, 1981.

The Cotton Valley Formation, Reservoir A was defined in Order No. 1158-B, effective August 25, 2009.

The Haynesville Zone, Reservoir A was defined in Order No. 1158-C, effective August 25, 2009.

A plat is available for inspection in the Office of Conservation in **Baton Rouge and Shreveport**, Louisiana.
