**LEGAL NOTICE**

**STATE OF LOUISIANA, OFFICE OF CONSERVATION, BATON ROUGE, LOUISIANA.**

In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Hearing Room, 1<sup>st</sup> Floor, LaSalle Building, 617 North 3<sup>rd</sup> Street, Baton Rouge, Louisiana, at 9:00 a.m. on **THURSDAY, SEPTEMBER 9, 2010**, upon the application of **ZACHRY EXPLORATION, LLC**.

At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the **4,300' Zone, Reservoir B**, in the South Bayou Mallet Field, Acadia Parish, Louisiana.

1. To establish rules and regulations and to create a single drilling and production unit for the exploration for and production of oil and gas from the 4,300' Zone, Reservoir B.
2. To force pool and integrate all separately owned tracts, mineral leases and other property interests within the proposed unit with each tract sharing in unit production on a surface acreage basis of participation.
3. To designate a unit operator and a unit well for the unit so created.
4. To provide that any wells drilled to the 4,300' Zone, Reservoir B shall be located in accordance with the spacing provisions of Statewide Order No. 29-E.
5. To provide that the Commissioner of Conservation may reclassify the reservoirs by Supplemental Orders without the necessity of a public hearing should such reclassification be warranted, based on evidence furnished by the Commissioner of Conservation.
6. To consider such other matters as may be pertinent.

The 4,300' Zone, Reservoir B is hereby defined as the stratigraphic equivalent of that oil and gas bearing zone encountered between the depths of 3,650' and 4,490' electric log measured depths in the Sklar Producing Co., Inc.-Lawrence Frey No. 1 Well, located in Section 25, Township 7 South, Range 1 West.

A plat is available for inspection in the Office of Conservation in **Baton Rouge and Lafayette**, Louisiana.
