Application is hereby made on behalf of **ANADARKO E&P COMPANY, LP** for the calling of a public hearing, after legal notice, to consider evidence relative to the issuance of an order pertaining to the following matters:

1. To create one (1) additional drilling and production unit for the exploration for and production of gas and condensate from the Austin Chalk Zone, Reservoir B, in the South Burr Ferry Field, Vernon Parish, Louisiana, said unit to be designated AUS C RB SUC, as shown on the plat attached hereto and made a part hereof.
2. To force pool and integrate all separately owned tracts, mineral leases and other property interests within the proposed unit with each tract sharing in unit production on a surface acreage basis of participation.
3. Except as otherwise provided, to extend to the proposed additional unit all pertinent provisions of Office of Conservation Order No. 1409-A, effective July 15, 1997, as amended and supplemented by the 1409-A Series of Orders, and applicable statewide orders.
4. To consider such others matters as may be pertinent.

The Austin Chalk Zone, in South Burr Ferry Field, Vernon Parish, Louisiana, was previously defined in Office of Conservation Order No. 1409, effective January 8, 1997.




