Application is hereby made on behalf of **Hilcorp Energy Company** for the calling of a public hearing, after ten (10) days legal notice, to consider evidence relative to the issuance of an order pertaining to the following matters relating to the 70 RB SUA located in the Caillou Island Field, Terrebonne Parish, Louisiana, for which rules and regulations were established and a drilling and production unit was created for the exploration for and production of oil and gas by Office of Conservation Order No. 411-XXXX, effective May 4, 2010.

1. To permit the applicant to designate and utilize its S. L. 301 No. 114 ST-2 Well as an additional alternate unit well for the 70 RB SUA, said well to be at the location shown on the plat attached hereto.
2. To permit the operator to produce the unit allowable from the existing unit well, the alternate unit wells, or the proposed additional alternate unit well, or from the combination of the wells at its option.
3. Except to the extent herein designated, to continue in full force and effect the provisions of Office of Conservation Order No. 411-XXXX.
4. To consider such other matters as may be pertinent to this application.

The 70 Zone, in the Caillou Island Field, Terrebonne Parish, Louisiana, was fully defined in Office of Conservation Order No. 411-XXXX, effective May 4, 2010.

The designation of the proposed additional alternate unit well would permit efficient and economic recovery of the hydrocarbons underlying said unit and is needed to satisfy the market demand for oil and gas from the field.

Pertinent data concerning this matter can be obtained **AT THE COST OF THE REQUESTING PARTY** from Mr. Randy McAlister at Leon E. Comeaux & Associates, P. O. Box 53922, Lafayette, Louisiana 70505 (337-233-9839).

There is attached hereto and made a part hereof a plat showing the applicant's proposal. Pursuant to the Revised Rules of Procedure, a list of names and addresses of the Interested Owners, Interested Parties and Represented Parties to whom this application is being sent is being furnished only to the Commissioner of Conservation and to the District Manager of the Lafayette District of the Office of Conservation. However, the list will be provided to any party requesting a copy. A diligent effort was made to ascertain the names and addresses of all Interested Owners, Interested Parties and Represented Parties as required by the Revised Rules of Procedure.

Finally there is enclosed our check on behalf of the applicant, Hilcorp Energy Company, in the sum of \$755.00 payable to the Office of Conservation and representing the required hearing application fee.


