

**TRACT 41596 - Portion of Block 45, Breton Sound Area, Plaquemines Parish, Louisiana**

The beds and bottoms of all water bodies belonging to the State of Louisiana located in Block 45, Breton Sound Area, together with any present lands formed by accretion to the shoreline or islands formed therein, located in Plaquemines Parish, Louisiana, owned by and not presently under mineral lease as of September 8, 2010, from the State of Louisiana, the geographical area of which is more fully described as follows: Beginning at the Northernmost corner of State Lease No. 17942, as amended, also being a point on the Southern boundary of State Lease No. 19391 having Coordinates of X = 2,688,438.19 and Y = 294,809.64; thence North 64 degrees 19 minutes 10 seconds East 2,121.35 feet along the boundary of said State Lease No. 19391 to its Southeast corner, also being the Southernmost Southwestern corner of State Lease No. 19052 having Coordinates of X = 2,690,350.00 and Y = 295,728.93; thence North 64 degrees 19 minutes 10 seconds East 1,387.01 feet along the Southern boundary of said State Lease No. 19052 to the Northernmost Northwest corner of State Lease No. 19051 having Coordinates of X = 2,691,600.00 and Y = 296,330.00; thence South 50 degrees 31 minutes 39 seconds West 3,347.00 feet along the Western boundary of said State Lease No. 19051 to its Westernmost Northwest corner, also being the Northernmost corner of State Lease No. 19347, also being the Northernmost corner of State Lease No. 15683, as amended, and the Easternmost corner of said State Lease No. 17942 having Coordinates of X = 2,698,016.35 and Y = 294,202.28; thence North 43 degrees 35 minutes 21 seconds West 838.54 feet along the Eastern boundary of said State Lease No. 17942 to the point of beginning, containing approximately **32.13 acres**, all as more particularly outlined on a plat on file in the Office of Mineral Resources, Department of Natural Resources. All bearings, distances and coordinates are based on Louisiana Coordinate System of 1927, (North or South Zone).

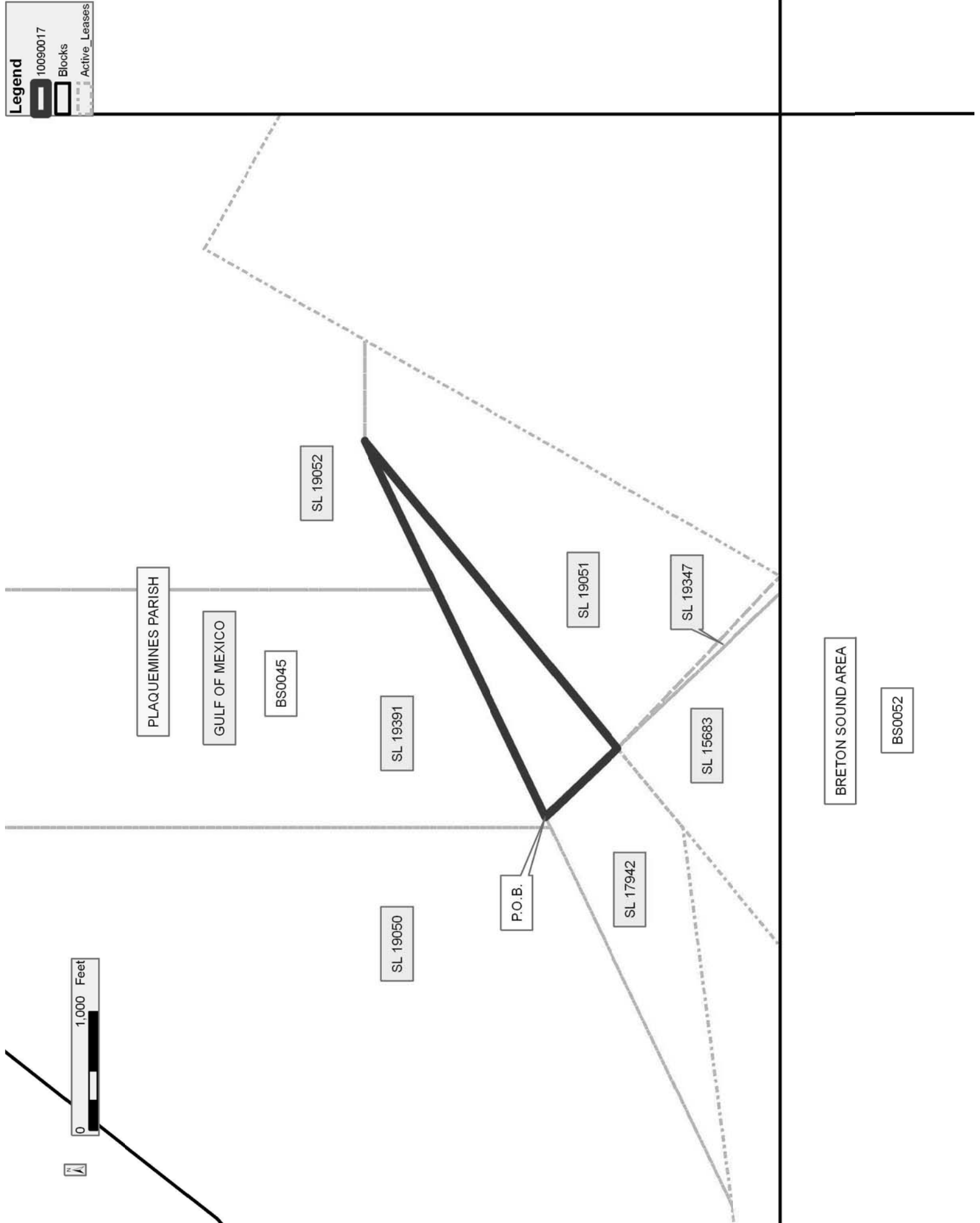
