This addendum shall be considered part of the Plans, Specifications, and Contract Documents (except as noted otherwise) and is issued to change, amplify, or delete from or otherwise explain these documents where provisions of this addendum differ from those of the original documents. This addendum shall have precedence over the original documents and shall govern.

I. Responses to Questions Submitted by Contractors:

Contractor Question/Comment (1): I have just left N.O. and am in Dallas. Unfortunately, I did not have access to this e-mail. We have just completed the H.P. Long Bridge revetment system for the State of Louisiana under Kiewit Construction. If I am not too late to bid this project, please give a call on my cell at 214-882-5207.

<u>CPRA Response (1)</u>: GP-5 Pre-Bid Conference and Site Visit – Bidders are required to attend the Pre-Bid conference and site visit (if held). Failure to attend will result in a null or void bid.

<u>Contractor Question/Comment (2):</u> We would like to plan a site visit this week. We have called and we have not been able to get in touch with anyone to schedule a site visit for this week. Could you please have someone give us a call? We have tried to call Mr. James Harris and Daniel Breaux.

<u>CPRA Response (2):</u> Daniel Breaux is the Refuge Manager. His phone number is (985) 882-2030 and e-mail is <u>Daniel.breaux@fws.gov</u>. If he is unavailable, the refuge headquarters and visitor center's phone number is (985) 882-2000. It is located on HWY 434, two (2) miles south of I-12 (exit 74).

Contractor Question/Comment (3): According to the bid the salt hardened is 10 parts per thousand. Water tested at located tested 2.2 parts per thousand. The question is do we have to mix our salt water to water plants on location?

<u>CPRA Response (3)</u>: TS-3.3.1 Plants shall be planted the same day they are delivered to the site if possible. Plants shall not become water stressed prior to planting. Plants shall retain their stem and leaf rigidity at all times indicating adequate moisture is being received. *Plants shall be watered with water within the salinity ranges in which they were grown.* The Contractor must take the necessary precautions to insure that the plant materials receive adequate water during all phases of the Contract prior to actual planting. Transplants must stay moist during mobilization and while on site prior to planting. Plants appearing discolored, shriveled, dehydrated, or otherwise stressed shall be rejected.

Contractor Question/Comment (4): In section 3.4.3 they state that plants should be planted 5 foot center with rows 10 feet apart, but on spec sheet Typical Plan layout sheet it has 3 foot center with rows 3 foot apart. What is the right center and distance of rows?

<u>CPRA Response (4)</u>: Plants are to be planted on five (5) foot centers with rows ten (10) foot apart. The Engineer reserves the right to modify the spacing and location of plants and rows; such modifications shall be accomplished through Change or Field Orders where appropriate.

Contractor Question/Comment (5): Reference the Pre-Bid conference held on October 22, 2013. Can you send me a copy of the sign in sheet from the mandatory pre-bid?.

CPRA Response (5): The Pre-Bid Meeting Sign-In Sheet will be included in Addendum 1.

II. Revisions to Specifications:

<u>Page 39, SP 16.1.3 Automobile Liability and SP 16.1.4 Excess Umbrella</u>: These sections are replaced in its entirety with the following:


16.1.3 AUTOMOBILE AND WATERCRAFT LIABILITY

Automobile Liability Insurance and Watercraft Liability Insurance shall have a minimum combined single limit per occurrence of \$1,000,000. ISO form number CA 00 01 (current form approved for use in Louisiana), or equivalent, is to be used in the policy. This insurance shall include third-party bodily injury and property damage liability for owned, hired and non-owned automobiles and/or watercraft. If any non-licensed motor vehicles and/or watercraft are engaged in operations within the terms of the contract on the site of the work to be performed thereunder, such insurance shall cover the use of any such vehicles.

NOTE: If the Contractor does not own automobiles and/or watercraft, and such vehicles are utilized in the execution of the contract, then hired and non-owned coverage is acceptable. If automobiles and/or watercraft are not utilized in the execution of the contract, then automobile and/or watercraft coverage is not required.

16.1.4 EXCESS UMBRELLA

Excess Umbrella Insurance may be used to meet the minimum requirements for General Liability, Automobile Liability, and Watercraft Liability only.
