This addendum shall be considered part of the Plans, Specifications, and Contract Documents (except as noted otherwise) and is issued to change, amplify, or delete from or otherwise explain these documents where provisions of this addendum differ from those of the original documents. This addendum shall have precedence over the original documents and shall govern.

I. Responses to Questions Submitted by Contractors:

Contractor Question/Comment (1): Will the successful bidder be required to pay Bacon-Davis?

CPRA Response (1): GP-4 *The Contractor shall abide by laws set forth in the Davis-Bacon Act of 1931* which states that all laborers and mechanics employed by recipients, the recipient's contractors, or subcontractors on this project shall be paid wages at rates no less than those prevailing on projects of a character similar in the locality as determined by the Secretary of Labor in accordance with Subchapter IV of Chapter 31 of Title 40 United States Code. Additionally, with respect to the labor standards specified in this section, the Secretary of Labor shall have the authority and functions set forth in Reorganization Plan Number 14 of 1950 (64 Stat. 1267; 5 U.S.C. App.) and The Copeland Act of Title 40 (40 U.S.C. § 3145). Prevailing Wage Determination Schedules, as determined by the United States Department of Labor, are provided in the Appendix. Prevailing Wage Determination Schedules are subject to modification by the United States Department of Labor. The Contractor is responsible for utilizing the most current Prevailing Wage Determination Schedule. These documents can be downloaded from the following link: <http://www.wdol.gov/cba.aspx#3>. Modifications to Prevailing Wage Determination Schedules shall be effective if received (or posted) no less than 10 days prior to bid opening.

Contractor Question/Comment (2): Can the plants be grown at nurseries outside of the State of Louisiana?

CPRA Response (2): SP-15.1 All plants shall be obtained from a Louisiana licensed nursery grower. All plants *shall be Louisiana-grown plant material and grown in Louisiana.*

II. Changes to Bid Opening:

The original Bid Opening was scheduled for January 7, 2014 at 2:00 pm. The new bid opening will be on Thursday, January 16, 2014 at 2:00 pm.
