EX PARTE MOTION FOR VOLUNTARY SUBSTITUTION OF DECEASED PLAINTIFF

NOW INTO COURT, through undersigned counsel, come Plaintiffs, August J. Levert, Jr., Family, LLC, *et al.* ("Plaintiffs"), who respectfully move for voluntary substitution of Thomas James Levert and John Michael Levert for Ronald R. Levert as plaintiffs in this matter.

- This lawsuit was filed on May 28, 2019, when individual plaintiff Ronald Raphael Levert was living.
- Ronald Raphael Levert passed away on or about January 15, 2022. He left no children, no spouse, and no parent surviving. Thomas James Levert and John Michael Levert are his brothers.
- On February 15, 2022, Judge Tarvald A. Smith of the 19th Judicial District Court signed an Amended Judgment of Possession in the matter of the succession of Ronald Raphael Levert. See attached Exhibit 1.
- 4. The Amended Judgment of Possession ordered that Thomas James Levert and John Michael Levert are recognized as legatees, and granted and placed into possession as owners in equal shares of Ronald Raphael Levert's property, including the property at issue in this matter. *Id.*
- 5. The Amended Judgment of Possession also expressly conveyed all the claims for damages made in this matter by Ronald Raphael Levert. *Id*.

- 6. The Amended Judgment of Possession was recorded in the Iberville Parish conveyance records. Id.
- 7. Louisiana Code of Civil Procedure article 801 provides:

When a party dies during the pendency of an action, which is not extinguished by his death, his legal successor may have himself substituted for the deceased party, on ex parte written motion supported by proof of his quality.

As used in Articles 801 through 804, "legal successor" means:

- (1) The survivors designated in Article 2315.1 of the Civil Code if the action survives in their favor;
- (2) Otherwise, it means the succession representative of the deceased appointed by a court of this state, if the succession is under administration therein; or the heirs and legatees of the deceased, if the deceased's succession is not under administration therein.
- 8. Pursuant to Louisiana Code of Civil Procedure article 801, Thomas James Levert and John Michael Levert are the legal successors of their brother, Ronald Raphael Levert, and should be substituted for Ronald Raphael Levert as plaintiffs in his matter.

WHEREFORE, Plaintiffs respectfully move to substitute Thomas James Levert and John Michael Levert, as legal successors of Ronald Raphael Levert, for Ronald Raphael Levert as plaintiffs in this matter.
