## COMMISSIONER'S CONFERENCE REPORT AND SCHEDULING ORDER

Pursuant to the request of the Louisiana Department of Energy and Natural Resources (DENR) and the Commissioner of Conservation, the Division of Administrative Law shall administer a public hearing, in the above matter, in accordance with the Louisiana Revised Statutes (La. R.S.) 30:29; Louisiana Administrative Code (LAC) 43:XIX.601 *et seq.*; and Louisiana Code of Civil Procedure Art. 1563.

A Commissioner's Conference was held by telephone on June 30, 2025, before the undersigned. Participating in the conference were Jonathan Rice, counsel for DENR; Stephen Olivier, panel coordinator and petroleum scientist; Kevin Huddell and Andrew Jacoby, counsels for Paul M. Levert *et al.* (Paul Levert); Victor Gregoire, John Funderburk, and Dylan Scully, counsels for Chevron U.S.A., Inc. (Chevron); Demarcus Gordon and Jane Jackson, counsels for Key Production Company, Inc. (Key Production Company.); Mark Deethardt, counsel for Union Texas International Corporation and Atlantic Richfield; and Paul Adkins, counsel for NOVA Chemicals Olefins, LLC.

The parties moved without objection to hold an in-person hearing at the Division of Administrative Law's (DAL) Baton Rouge office in courtroom 1. The hearing is scheduled to

begin August 12, 2025, at 10:00 a.m., August 13, 2025, at 10:00 a.m., and if necessary, August 14, 2025, at 1:00 p.m., ending no later than 5:00 p.m., each day, if possible.

The undersigned will conduct the hearing. Four panel members will render the decision. The panel members have not been named. Stephen Olivier of DENR will be the panel coordinator. Based on estimates given during the conference, there will be about 33 people attending the hearing. The parties reported there are no outstanding motions at this time.

Chevron and Key Petroleum Company plan to present their case in one and a half days. Union Texas International Corporation, Atlantic Richfield, and NOVA Chemicals Olefins, LLC, will present their scientific basis for their filed comments in 15 minutes. Paul Levert plans to ask questions, perform cross and rebuttal for about a half an hour for each witness. Paul Levert has no witnesses other than possible rebuttal.

Chevron is responsible for arranging the services of a court reporter. The court reporter or any party may call **Diab Haddad**, **the IT manager for the Division of Administrative Law**, **at (225) 342-1800**, if they have any questions, need help setting up for the hearing, or would like to visit DAL courtroom 1 to prepare technical equipment for the hearing.

Deadlines for the exchange of witness lists, exhibit lists, exhibits, and legal authority as well as deadlines for the filing of motions were chosen with the consent of the parties. The parties may call the **Division of Administrative Law's clerk's office at (225) 342-1800** if they have any questions or need assistance filing documents with the Division of Administrative Law. Documents can be filed by U.S. Mail, email, fax, or in person. All video and audio recordings that are offered as evidence during the hearing must be submitted on one of the following: CD, DVD, or flash drive. Audio and video evidence must be mailed or hand-delivered to the Division of Administrative Law.
