The Commissioner of Conservation proposes to amend LAC 43:XI. Chapter 35; LAC 43:XIII:Chapters 3-35 and LAC 33:V. Chapter 30105-30452 in accordance with the provisions of the Administrative Procedure Act R.S. 49:950 et seq., and pursuant to the power delegated under the laws of the state of Louisiana.

II. Statement of the proposed action per La R.S. 49:968.C(2):

The Louisiana Office of Conservation proposes to amend LAC 43:XI. Chapter 35; LAC 43:XIII:Chapters 3-35 and LAC 33:V. Chapter 30105-30452 in accordance with the provisions of the Administrative Procedure Act R.S. 49:950 et seq. The proposed rule changes for LAC 43:XI are to modify existing Carbon Dioxide rules; the rule changes for LAC 43:XIII:Chapters 3-35 and LAC 33:V. Chapter 30105-30452 are required as a part of the Department of Natural Resources certification agreement with the US Department of Transportation and are intended to adopt existing federal regulations as state regulations.
